PROBABLE CAUSE

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, who was positively identified by his state of Florida Driver's License, on the 13 day of October, 2020, at approximately 10:19 [] A.M. [x] P.M. at 4860 Irving Street within St. Johns County, violated the law and did then and there:

F.S.S.: 782. 04.1a1 Murder – First Degree

On Tuesday, October 13, 2020, at approximately 2219 hours, St. Johns County Sheriff's Office patrol deputies responded to 4860 Irving Street in regards to a stabbing. The 911 caller/witness stated the defendant, DERREK PERKINS, stabbed the victim and fled the residence. Patrol deputies arrived on scene and located the victim on the front porch with multiple stab wounds. St. Johns County Fire/Rescue arrived on scene and pronounced the victim deceased at approximately 2235 hours.

Detectives responded to the scene and interviewed witnesses. According to one witnesses sworn testimony, she was inside the residence when she heard her dog barking at the window from inside, but didn't think anything was wrong. This witness advised her daughter called and advised she was on her way home with the victim. A short time later, her daughter and the victim arrived home and this witness advised she heard screaming and a bang at the front door. This witness stated she heard the victim yelling "Help me!" multiple times and when she opened the front door she observed the victim lying in blood in a fetal position and the defendant was standing off towards the victim's left in front of a swing. This witness advised the defendant then ran across the front porch and down the stairs. This witness advised she grabbed her phone and called 911 and screamed for her daughter. This witness stated she knew the defendant by name and confirmed the defendant's identity by photograph.

Another witness provided sworn testimony advising she picked up the victim from work and returned to the residence. This witness stated due to previous and current issues the victim had with the defendant, they circled the block looking for the defendant's vehicle. Once they believed it was safe, this witness parked her vehicle across the street and together she and the victim walked to the front of the residence. This witness stated she followed the victim up the steps to the front porch and once at the top of the steps, this witness turned to close a pet gate when the defendant pushed past this witness. This witness in fear for her own safety ran down the steps and crawled under the residence as far as she could. This witness stated she could hear the victim yelling "Help me!" multiple times but could not see what was happening. This witness stated not long after, she heard the defendant's vehicle driving away and heard her mother screaming for her. According to the witness she then came out from under the residence and began CPR on the victim. This witness stated she knew the defendant by name and confirmed the defendant by photograph.

The defendant was apprehended at approximately 2232 hours in the area of State Road 207 and Morrison Road. Upon contact with the defendant, he appeared to have droplets of blood on his legs.

On Friday, October 9, 2020, the defendant committed aggravated assault against the victim when he tried to run her over in his vehicle as she walked across the parking lot. The defendant fled the area and was unable to be located. Criminal charges were filed; reference SJSO20OFF008790.

On Monday, October 12, 2020, the victim obtained an injunction signed by the Honorable Judge Alexander against the defendant. At the time of this incident, the defendant had not been served the injunction; reference DR20-1491.

On Tuesday, October 13, 2020, the defendant had criminal charges filed for petit theft after he entered the victim's place of employment and stole her purse. The defendant avoided apprehension by fleeing the scene; reference SJSO20OFF008886.

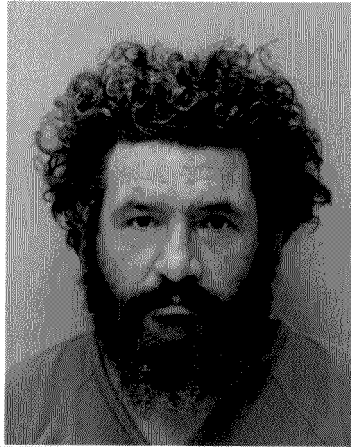
