fire pos wit	A firearm was turned over to the Flagler County Sheriff's Office from Tracie Harmon, who is Dorothy's sister. The firearm was a five (5) shot .22 handgun North American Arms. Tracie advised that Dorothy had the firearm in her possession for approximately one (1) year and returned it over to Tracie approximately 2 months ago. This is consistent with the time frame in which Charles was last seen.								
ex _l	This firearm was sent to FDLE for an analysis to determine if this was the firearm used to in the murder of Charles. An expert with FDLE has indicated this firearm cannot be excluded as the possible murder weapon. The FDLE report issued on April 14, 2017 states that a bullet and bullet fragment collected at autopsy were identified as .22 caliber class and having been fired from the same firearm.								
On May 7, 2017, the FCSO was contacted by a confidential informant (C.I.) who advised they were contacted by Dorothy Singer and her sister Tracie Harmon and told that they were planning to fake Dorothy's death and needed to get her out of Flagler County before FCSO arrested her. Dorothy and Tracie asked the C.I. to drive to Florida to pick up Dorothy and take her out of state. A controlled phone call was made on May 7, 2017 between the C.I. and Dorothy Singer wherein Dorothy stated that this was her own fault, for putting herself in this situation.
