On March 26, 2015, Agents with the Florida Department of Law Enforcement and the Flagler County Sheriff's Office executed a Search Warrant at 22 Buffalo Meadow Lane, Palm Coast, Florida.

The defendant stated that he knew the images and videos of child pornography were illegal, but he possessed and transmitted them anyways. The defendant stated he would use the mobile application KIK to trade child exploitation material with other persons.

SA Whiteside advised that based on the evidence and the defendant's statements, there was probable cause to arrest the defendant.

The defendant was placed under arrest by FCSO Deputy F. Ebrill and transported to the Flagler County jail without incident.
