The defendant unlawfully sell, manufacture, or deliver, or possess with intent to sell, manufacture, or deliver, cannabis, a controlled substance in, on, or within 1000 feet of the real property comprising a public housing facility as defined in section 421.03(12) at any time, contrary to Florida Statute 893.13(1)(f).

The defendant unlawfully and knowingly in actual or constructive possession of drug paraphernalia being used, intended for use, or designed for use in injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance, contrary to Florida Statute893.147(1)(b). (1 DEG MISD)

To wit: On April 19th 2010 this officer obtained a search warrant for 311 S. Bacher St. The warrant was signed by the Honorable Flagler County Circuit Judge Kim C. Hammond.

On April 22, 2010 at about 05:35am the Bunnell Police Department, including this officer, served said warrant. When team members entered the house, Mr. Curtis Emanuel was lying on the living room couch. Mr. Predaran Barnes was lying on the bed in the second bedroom. Both subjects' were quickly detained and the search warrant was executed.

Sergeant Gamarra and Officer George Hristakopoulos searched the residence. I collected evidence. Located on the top of the couch, that Mr. Emanuel was lying on, was a small plastic bag containing cannabis. A piece of cocaine (Crack) was located behind the same couch. A small draw string bag, containing 18 individually packaged plastic bags of cannabis was located next to the above couch. A small black trash can containing a small plastic grocery type bag was located next to the above coach. This plastic contained two small red plastic bags containing small of amounts of cocaine, several small pieces of cannabis (Stem), a small plastic bag, cigar casing, and what appeared to be tobacco shavings.

A brown purse type bag was located in the master bedroom. This bag contained a larger plastic bag containing about 50-60 grams of cannabis, a bag of small plastic bags (that matched in color and size as the above individually packed bags of cannabis), a plastic bag containing orange "bear" type plastic bags, a digital scale with cannabis residue, a large gallon size Ziploc bag containing plant residue, a gallon size plastic bag containing seeds and small pieces of cannabis, a small plastic bag containing six blue pills that were identified as Hydrocodone and small pieces of cannabis at the bottom of the bag.

A Hi-Point .45 ACP semi-automatic handgun was located on the dress in the second bedroom. A box of fold and lock sandwich bags was located onto of a box in the living room. Five cell phones were located on the living room end table. Mr. Emanuel had four hundred fifty four dollars was located in his pocket.

At about 06:10am, after searching the home for about 20 minutes, the home owner, Ms. Takesha T Johnson came on scene. Ms. Takesha was served a copy of the search warrant at that time and arrested.
