
- I) SEX BATTERY; ENGAGE SEX CONDUCT, MINOR 12 TO 18 YEARS BY PERSON IN FAMILIAL OR CUSTODIAL AUTHORITY
- II) UNLAWFUL SEXUAL ACTIVITY WITH A MINOR

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: SEAN PATRICK FARRELLY on or between February 24, 2018 and February 14, 2019, in the County of FLAGLER and State of Florida, did unlawfully engage in sexual activity with S.J.C., a child 12 years of age or older but less than 18 years of age, while SEAN PATRICK FARRELLY was in a position of familial or custodial authority over S.J.C., by inserting the penis of SEAN PATRICK FARELLY into the vagina of S.J.C. , contrary to Florida Statute 794.011(8)(b). (1 DEG FEL)

COUNT II: IN THAT SEAN PATRICK FARRELLY on or between February 24, 2018, and February 14, 2019, in the County of FLAGLER and State of Florida, did, while 24 years of age or older, engage in oral, anal, or vaginal penetration by, or union with, the sexual organ of S.J.C., or SEAN PATRICK FARRELLY did engage in the anal or vaginal penetration by any other object, of S.J.C., a person 16 or 17 years of age, contrary to Florida Statute 794.05 (2 DEG FEL)
