The mission of the Flagler County Cultural is to build unity among member organizations, engage in advocacy and education in support of the arts and humanities and to seek and provide resources to enrich the lives of its residents and visitors.

The Cultural Council envisions a vibrant community unified in support of the arts, history, and cultural heritage as essential enrichment for the residents and economy of Flagler County.

Our purpose for this grant is to create an outdoor music series (one per quarter) which may also include craft vendors and food trucks and the opportunity for our not-for-profit members to promote their organizations.

Dates and times of the events are fluid at the time of this grant, but each calendar quarter it is our plan to provide these outdoor concerts to the community at the former Palm Coast Arts Foundation outdoor stage at 1500 Central Avenue in Town Center. The benefit of the vast space, ample parking and restroom facilities on site make this a perfect venue.

The outdoor events will allow residents to mingle and enjoy the outdoors while entertained by professional musicians in a "bring your own chair/blanket" atmosphere. A variety of music genres will be explored to reach diverse generations. A minimum of 200 guests are expected at each event.
