Antonio escalated the assault when he pulled out a knife, placed it at her neck, then raped her. [REDACTED] under duress, fearing for her life did not try to fight off Antonio as he was raping her. Shortly later, [REDACTED] was able to break free and managed to exit the apartment through the back sliding glass door. Antonia chased [REDACTED] as she was getting into her black [REDACTED] Antonio caught up with [REDACTED] as she was in her vehicle, then put her in a choke hold to the point she could not breathe. [REDACTED] was coming close to passing out, "seeing stars" and heard an elderly female yelling for help. At this time, knowing Antonio was attracting unwanted attention, he fled the scene and drove off in his white 2016 Subaru, FL 9165XS towards E Moody Blvd.

[REDACTED] suffered physical injuries to her neck and right arm from the assault that occurred in her residence and in her vehicle done by Antonio. [REDACTED] was transported to Advent South Medical Center in Palm Coast pending treatment and to be examined by Sexual Assault Nurse Examiner.

The above scene was secured by BPD pending the FCSO Crime Scene unit to arrive.

[REDACTED] gave written consent to have her apartment searched and processed.

I was notified of the above incident and within minutes I arrived to the scene. With the assistance with the FCSO Crime Scene Unit, the scene was processed

A BOLO was immediately put out for Antonio's Subaru and through investigative means, St. Johns Sheriff's Office located Antonio driving north bound on I-95 near the intersection of SR 207. A traffic stop conducted and Antonio was secured pending an arrest warrant.

I, Detective Traylor, was notified of the incident and immediately responded to the above scene where I met with FCSO Crime Scene and directed them to the scene where they started photographing and processing the scene.

I then arrived at Advent South Medical Center and met with [REDACTED] who was with BPD Officer Ingino.

[REDACTED] gave a detailed statement to me that was recorded on my BWC.

[REDACTED] informed me this morning she arrived to her residence this morning at approximately 0700 hours, then took her children to the daycare center in Bunnell. When she arrived back to the residence at approximately 0900 hours, she was facetimeing with her friend when her phone lost connection and read SOS only. As [REDACTED] was checking on her internet, she observed Antonio disabling the internet and discovered he made unlawful entry into her apartment through the window. Antonio did not have permission to enter the apartment. [REDACTED] became extremely scared and feared for her life since Antonio had done this before and had threatened her. Antonio had a COVID 19 mask on his face and had gloves on both hands. [REDACTED] tried to get away and screamed for help. At this time, Antonio grabbed [REDACTED] over her mouth preventing her screams to be heard and also making it difficult for her to breathe. [REDACTED] knew Antonio was going to cause great harm to her and stopped screaming. When Antonio released his hands from [REDACTED] mouth, she started screaming for help again hoping someone would hear her. Antonio then put his hand over [REDACTED] mouth again, and around her neck and forced her onto her bed. Then Antonio pulled out his black and blue pocketknife, extended the blade, and put the blade to [REDACTED] neck wanting to have sex with her. [REDACTED] was totally under duress and knew she had to comply or he was going to harm her. [REDACTED] quit struggling as Antonio pulled off his pants then he pulled off [REDACTED] pants at which time he had forcible vaginal intercourse with her. When the forcible sexual act was done, [REDACTED] managed to quickly get up and escape by exiting the apartment through the sliding back glass door. However, Antonio gave chase as [REDACTED] was running towards her vehicle. Antonio caught up with [REDACTED] and forced his way into her vehicle. Then Antonio put his arm around [REDACTED] neck (choke hold) and choked her to the point [REDACTED] could no longer breathe and was seeing stars. [REDACTED] heard an elderly female yelling for help and at this point Antonio fled from inside [REDACTED] vehicle, entered his Subaru and drove away.

During the above assault after [REDACTED] discovered Antonio was inside her residence, he immediately took all three of [REDACTED] cell phones preventing her to call for police help. Antonio further snatched the outside surveillance camera that located outside the back sliding glass doors. Antonio took all the devices with him as he left. The surveillance camera was later found under [REDACTED] vehicle photographed and collected. [REDACTED] and threats to kill [REDACTED]

[REDACTED] informed me the knife that Antonio used against her [REDACTED]
