THE GRAND JURY CHARGES:

COUNT ONE

False Statement During the Purchase of a Firearm

On or about February 4, 2019, in the District of Puerto Rico and within the jurisdiction of this Court, the defendant,

ANTONIO FIGUEROA-ACEVEDO,


in connection with the acquisition of a firearm, that is, a Century Arms Micro Draco, bearing serial number PMD-06040-1B, from Armeria Bam Bam Guns and Sports Shop, a licensed dealer of firearms within the meaning of Chapter 44, Title 18, United States Code, knowingly made a false and fictitious written statement to Armeria Bam Bam Guns and Sports Shop, which statement was intended and likely to deceive Armeria Bam Bam Guns and Sports Shop, as to a fact material to the lawfulness of such sale of the said firearm to the defendant under chapter 44 of Title 18, that is, the defendant represented on an ATF Firearms Transaction Record Form 4473 that he was the “actual buyer”, when in truth and in fact, as the defendant well knew, he was purchasing the firearm on behalf of an individual identified as J.G.O. All in violation of 18 U.S.C. §§ 922(a)(6) and 924(a)(2).


FIREARMS AND AMMUNITION FORFEITURE ALLEGATION

The allegations contained in this indictment are hereby re-alleged and incorporated by reference for the purpose of alleging forfeitures pursuant to 18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c). Upon conviction of the offense set forth in Count One of this indictment, the defendant, **ANTONIO FIGUEROA-ACEVEDO**, shall forfeit to the United States pursuant to 18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c), any firearms and ammunition involved or used in the commission of the offense, including, but not limited to: a Century Arms Micro Draco, bearing serial number PMD-06040-1B.
