At 16:08 hours Dep. Miller conducted a traffic stop on the Toyota Camry bearing Florida tag V135EZ at the intersection of Palm Harbor Parkway and Colorado Drive, regarding a traffic infraction. The vehicle operator was identified as Mr. William Fleming, white/male, and the passenger, [REDACTED], white/female. I made contact with Mr. Fleming in the driver's seat at which time he exited the vehicle to speak with me. Mr. Fleming stated that he was headed to [REDACTED]'s residence to drop her off after picking her up. At this time Mr. Fleming provided verbal consent to search his vehicle. He stated that this vehicle is a rental due to his vehicle being in the shop. A check of FCIC/NCIC showed that [REDACTED] is on probation for grand theft. A condition to her probation is she must submit to search. [REDACTED]

During the search multiple prescription pills and drug paraphernalia were located. Through discussion with [REDACTED] she stated that when Mr. Fleming observed the patrol lights he handed her a Marlboro cigarette package containing 3.5 Xanax pills. He told her that he would bail her out if she was arrested. [REDACTED] provided a voluntary written statement pertaining to these facts.

I then spoke to Mr. Fleming who stated that he did not know anything about any pills and does not have a narcotics problem. I then walked away from Mr. Fleming at which time he called me back to him. At this time Dep. Erlandson provided him with his Miranda Rights. [REDACTED]

Mr. Fleming was placed under arrest for possession of scheduled IV narcotics without a prescription. He was transported without incident to the Flagler County Inmate Facility. [REDACTED] was released on scene. Charges will be filed on [REDACTED] regarding additional narcotics after this investigation is complete.

The male parked on the roadway for approximately a few minutes when a white female exited the home and entered the vehicle. The female was wearing a light blue and gray sweatshirt with teal scrubs. The vehicle then made a u-turn and left the area. At this point mobile surveillance was conducted on the vehicle. While following the vehicle it was observed that the white male driving the vehicle was having trouble maintaining his lane of travel. A traffic stop of the vehicle was conducted by Deputy Miller. During the stop the driver of the vehicle gave deputies consent to search the vehicle.

While searching the vehicle I did not find any illegal weapons or narcotics. Deputy Erlandson searched the passenger's purse where he located several prescription pills and paraphernalia.

The passenger told me that the driver handed her a Marlboro cigarette pack that had some pills in it and that if she gets in trouble he would get it taken care of. The passenger said that she does not want the driver to get in trouble but she wants him to get help. The passenger completed a voluntary statement.
