NARRATIVE		The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 19TH day of March , 2006 , at approximately 1400 <input type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m. at 9 PINE CONE DRIVE PALM COAST, FL within Flagler County, violated the law and did then and there: The victim, a 26 year old female, went into Dr. Fruehan's office to see him in reference to a possible urinary tract infection. The victim was in a room with her husband and waiting for the doctor when he came in and asked the victim what her reason for being there. The victim stated that she had pain with urination. Dr. Fruehan (the defendant) walked out of the room and a nurse came in and told her to undress from the waist down. The defendant came in a short time later and called in a nurse. The victim's husband was also present. The victim states that Dr. Fruehan placed his fingers in her vagina and began pressing on her stomach. The victim stated that this went on for a minute. The victim advised that she did feel pain. Dr. Fruehan then placed his fingers back into her vagina and began moving his fingers back and forth "like an intercourse motion." The victim stated that Dr. Fruehan did place his hand on her stomach, but did not push on her stomach at this time. The victim states that this went on for approximately 2 minutes and was forceful at during this time. The victim advised that Dr. Fruehan placed the clamp back in her vagina and asked her husband if he wanted to see. The victim's husband told him that he knew what it looked like, but Dr. Fruehan told him that he probably has not seen it like this before. The victim left the office shortly after the exam and believes that the nurse was aware that what happened during this incident was not right. The victim and her husband went back to the office to talk with the nurse, but Dr. Fruehan advised them that he would answer any of their questions. The victim and her husband abruptly left the office when they found out that Dr. Fruehan was coming out to the lobby.
