thii ow 11 from how case Ver a verification of the search	My next interview was conducted at Giuseppe Verdones family's residence located at 64 Bannerwood Lane, Palm Coast. I spoke to Daniela (Giuseppe's mother), and this interview all parties were extremely cooperative. Daniela, all advised that Giuseppe does not own a vehicle and very rarely has money on him. Giuseppe arrived at his mother's home at approximately 10:00 P.M., 11/02/2013, driving a vehicle, which is uncommon. It should be noted 64 Bannerwood is approximately 200 yards from where the delivery location was set up from the Chinese Restaurant, 78 Bayside Drive. When Giuseppe arrived home he entered the home and retrieved a laptop computer and a gas container from the garage. Giuseppe also had cash which he showed to his brothers; they both advised it is uncommon for Giuseppe to have cash on him. The Verdone residence has video surveillance on the outside of the home. I witnessed this video surveillance and observed a vehicle pull up to the residence and observed Giuseppe exit the vehicle. At this time the vehicle is unable to be identified due to the quality of the footage. Giuseppe's younger brother stated he observed metal handcuffs on Giuseppe earlier in the day. described these handcuffs as heavy metal with initials inscribed in them: this description matches the handcuff's that were removed from the victim. I then reviewed the laptop that Giuseppe used searching the history. I found that Giuseppe conducted research on a Motel 8 located in Vignina. I immediately placed a BOLO for the 1-95 North Bound Corridor due to the possibility that the suspect was traveling in a northerly direction. Shortly after Giuseppe was arrested by the Mardeeville Police Department after a high speed chase took place. This pursuit started in Georgia and lasted approximately 45 minutes and ended in Mardeeville which is located in South Carolina. Giuseppe was in possession of the victim's vehicle which is a gray 4 door Toyota. Giuseppe had a female passenger with him that was identified as Giuseppe varied by the victim's vehi
