

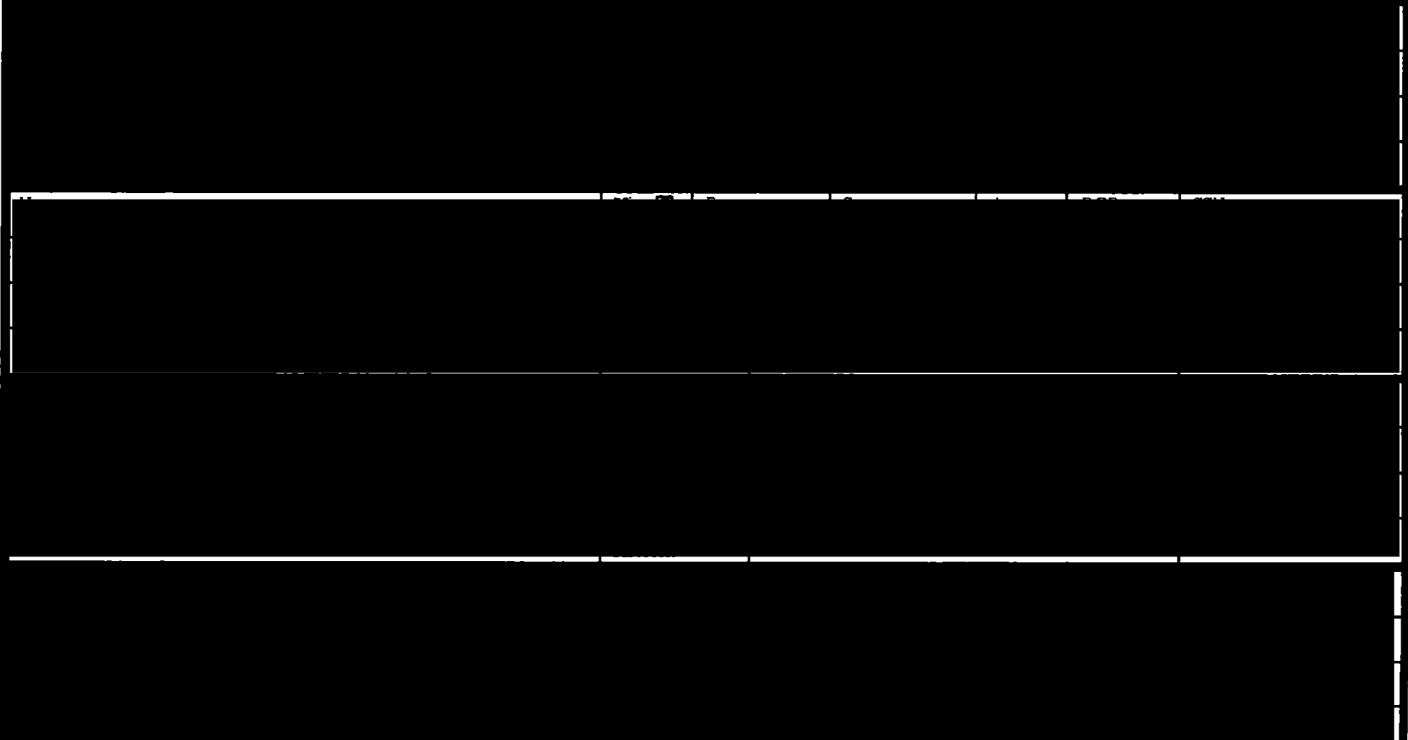

without his permission. Rashad stated that he had been dating Shantana "on and off," and that he was not expecting her to come over, nor was she invited.


Rashad stated that he left his front door open for his kid to play. Rashad advised that he was lying in his bed when Shantana entered his room, snatched his cell phone from his hand, and left the residence. Rashad stated that Shantana returned to the residence approximately 20 minutes later, driving a white Tesla bearing FL tag, "73EZRJ." Rashad explained that Shantana entered through the front door and began attacking him. Rashad further elaborated, advising that Shantana attempted to strike him, and that he defended himself by grabbing her by the wrists. Rashad stated that Shantana proceeded to bite his right arm. I observed a red mark on Rashad's right bicep with consistent characteristics of a bite mark.

Rashad stated that Shantana proceeded to enter his bedroom, pulling paintings off the wall, and attempting to throw a television to the ground, which, in doing so, she caused damage to a sound bar, which Rashad estimated to be \$200-\$300. Rashad stated that Shantana exited the residence, walking around towards his bedroom window, and attempted to open it. Rashad advised that Shantana broke his bedroom window when she couldn't open it. Rashad advised that Shantana then left the residence, in an unknown direction.

Photos were taken of Rashad's injuries and the damaged window and sound bar. Rashad completed a willingness to prosecute form, a victim's rights to confidentiality form, and a sworn domestic violence assessment and statement form. Rashad's answers to the first five assessment questions are as follows:

1. Has the aggressor ever used a weapon against you or threatened you with a weapon? "Yes,"
2. Has the aggressor ever threatened to kill you or your children? "Yes",
3. Do you think the aggressor is capable of killing you? "Yes",
4. Has the aggressor ever choked you or attempted to choke you? "Yes",
5. Does the aggressor have a gun or could the aggressor easily obtain a gun? "No".

Coast, Florida 32164. Upon no contact being made, Rashad called 9-1-1 again, advising that Shantana returned to the residence and was currently inside. Deputies arrived back on scene at [REDACTED]. I observed Shantana look at my agency patrol vehicle with marked insignia and red and blue lights activated. Shantana quickly entered the residence, fleeing from deputies. A perimeter was established around the residence. Upon clearing the residence, Shantana was not located inside.

It was later determined that Shantana brought her three children with her, who were later identified as [REDACTED], while she was involved in the altercation with Rashad. Shantana abandoned her children when she fled from deputies, leaving them stranded in the middle of the street. Due to the children's ages, proximity to vehicle traffic, and no way to return home or contact their father, the children were exposed to a foreseeable risk of being injured.

Due to Shantana taking Rashad's cellphone from his hand, temporarily depriving him of the cellphone, and in doing so, Rashad was aware of the taking, Shantana is being charged with Robbery Sudden Snatching.


Due to Shantana entering the residence without permission or invitation and committing another offence therein (Domestic Battery), she is being charged with Burglary with Battery.

Due to Shantana fleeing upon sight of law enforcement, evading custody, Shantana is being charged with Resisting Officer Without Violence.

Due to Shantana's willful failure to provide her three children with care, supervision, and services, leaving them in the middle of the street with no way to get home or contact a family member, she is being charged with three counts of Child Neglect.

Due to Shantana willfully and maliciously damaging Rashad's property (soundbar and window), she is being charged with Criminal Mischief (\$200-\$1000).

[REDACTED] father was identified as Cory Favors. Contact was made with Cory, who designated an Aunt (Kathryn Neeley) to pick up the children and take them to his residence. A DCF
