The Defendant and Victim were in the process of working on a travel trailer, to make it into a residence. They were arguing, and the Victim yelled at the Defendant, calling him a "child molester." The Defendant became enraged and grabbed a black handle kitchen knife. The Defendant approached the Victim, saying, "You want to see a child molester?" He held the knife toward the Victim's person, in a threatening manner, and stated, "I should, but I won't kill you. I will just make you blind." The Victim was in great fear of great harm.

The Defendant did knowingly and willingly commit the offense of Aggravated Assault, by using a black handle kitchen knife to threaten the Victim, placing her in fear of great harm.

On 06/09/2012, Dep. Stokes 3221 and I were dispatched to 10275 Zigler Avenue, Hastings, reference a disturbance. Communications stated the male suspect threatened the female with a knife. Communications stated the male was wearing a white tshirt and black pants. As we arrived at the residence, I observed a male matching the description, walking from a vehicle at the residence. I immediately exited my vehicle, and made contact with the male, later identified as Darnell Hairston. D. Hairston stated, "I didn't use a knife on her." After patting D. Hairston for safety, I asked him what was going on. He stated he was working on a travel trailer with a friend from work, [REDACTED]. He stated they started arguing, and she called him a child molester. D. Hairston stated he was

upset by the comment, so he took a computer. He stated he purchased the computer, however, he was allowing L. [REDACTED] to use it. He said she told him she would get him in trouble with the police. I asked him if he would give me a written statement. He said yes.

I made contact with [REDACTED] inside the residence on the property. [REDACTED] was extremely upset, and crying uncontrollably. I asked her if she needed medical attention. She stated no. She told me how she was arguing with D. Hairston. She stated he was calling her numerous negative names. She admitted she called him a child molester, due to his past. She stated she was sitting on her bed, inside the travel trailer. She stated he said, "You want to see a child molester?" She said she was in fear from the sound of his voice, so she just sat on the bed. D. Hairston came into the room, holding a black handle kitchen knife. He put his hand toward her throat, and said, "I should, but I won't kill you. I will just make you blind, bitch. Call me a molester again, bitch." [REDACTED] said she was in great fear of personal harm, so she froze for a moment.

She stated D. Hairston got up and walked out of the room. She stated she got up and watched him put the knife in a wooden knife holder, and place it into a vehicle belonging to him. I asked her if there were any witnesses to the attack. She stated they were the only persons in the travel trailer. I asked her what relationship she had with D. Hairston. She stated they knew each other from her work, and he was trying to help her get a place to stay. She stated they were not romantically involved. I asked her if she was willing to give me a written statement. She said yes. I did not observe any marks on her neck or face area. [REDACTED] stated he barely touched her.

I asked D. Hairston why he stated, "I didn't use a knife on her." He stated he heard me say that to him when I exited my vehicle. I advised him I never mentioned anything about a knife to him. I asked him to tell me about any knives. He stated [REDACTED] knew about all his knives, so she would be able to describe all of them. I asked him what knives he thought she was telling me about. He said he had a lot of them in an old vehicle, which did not run. I asked him if he would show me the knives he thought [REDACTED] was referring to. He produced a wooden knife holder, with 8 black handle knives in the proper slots. I took the knife holder from D. Hairston, and explained how the holder and knives would be detained for my investigation.

I spoke with [REDACTED] and asked her to tell me what the knife looked like. She stated the knife was longer and bigger than a steak knife, however, it was kept in the same wooden holder with steak knives and a very small knife. I observed there were 6 steak knives and a small peeling knife, with a larger cutting knife, all in the wooden holder I had taken possession of. I read through the written statement from D. Hairston. I observed he said nothing in his statement about [REDACTED] statement regarding a knife, but he did make special attention to [REDACTED] calling him a child molester. I asked him why the name-calling affected him. He stated he has a past conviction, and when she called him that, he couldn't believe what he heard.

He asked me if I was going to arrest him. I explained how there was no damage to [REDACTED] however, the description of the knife, and the totality of the circumstances warranted me to make an arrest. I explained what the charge was, and placed him in handcuffs, checking them for proper fit, and double locked them for safety. I placed D. Hairston in the back seat of my patrol vehicle. While preparing my paperwork, D. Hairston told me he has issues where he gets stressed, and "blacks out." I asked him if he thought they may have happened. He stated he never wanted to hurt [REDACTED] he wants to get her away from all the junk in her past. I transported D. Hairston to the Jail. I entered the evidence into the Evidence Section.
