- II) LEWD/LASCV EXHIBIT PRSN 18 YOA/OLDER VIC <16
- III) LEWD/LASCV MOLEST 18 YR/OLD-VIC 12 UP TO 16YR (DIRECT)

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: JAMES EDWIN HARRIS on or between September 1, 2016, and August 31, 2018, in the County of FLAGLER and State of Florida, JAMES EDWIN HARRIS, a person 18 years of age or older, did unlawfully and intentionally touch V.M., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice V.M. to so touch V.M., in that JAMES EDWIN HARRIS did touch the breasts and/or genitals and/or genital area and/or buttocks of V.M., contrary to Florida Statute 800.04(5)(b). (LIFE FEL)

COUNT II: IN THAT JAMES EDWIN HARRIS on or between January 1, 2021, and July 1, 2021, in the County of FLAGLER and State of Florida, JAMES EDWIN HARRIS, a person 18 years of age or older, (a) did unlawfully and intentionally masturbate or expose the genitals in a lewd or lascivious manner {or} did intentionally commit a sexual act that does not involve actual physical or sexual contact in the presence of V.M., a person less than 16 years of age, by intentionally masturbating in the presence of V.M., contrary to Florida Statute 800.04(7)(b). (2 DEG FEL)

COUNT III: IN THAT JAMES EDWIN HARRIS on or between September 1, 2018, and March 31, 2020, in the County of FLAGLER and State of Florida, JAMES EDWIN HARRIS, a person 18 years of age or older, did unlawfully and intentionally touch V.M., a person 12 years of age or older, but less than 16 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice V.M. to so touch JAMES EDWIN HARRIS, in that JAMES EDWIN HARRIS did touch the breasts and/or genitals and/or genital area and/or buttocks of V.M., contrary to Florida Statute 800.04(5)(c). (2 DEG FEL)



