<p>The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the <u>30</u> day of <u>June</u>, 2017, at approximately <u>1200</u> <input checked="" type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m. at <u>29 Red Clover Lane</u> within <u>FLAGLER</u> County, violated the law and did then and there:</p> <p>Deliberately assist in the self-murder of his girlfriend:</p> <p>On June 30th 2017 at 7:18 PM the Flagler County Sheriff's Office responded to 29 Red Clover Lane, Palm Coast Florida, 32137 in reference to a death investigation.</p> <p>Flagler County communications division received a 911 phone call from Raquel Schiccnvoight who reported that mother, Katherine Goddard and her mother's boyfriend, Bruce Haughton were in their vehicle in the garage. It was further reported that her mother was unresponsive without a pulse and Bruce was breathing.</p> <p>Deputy Jacob arrived on scene first and observed a gold Ford Escort, bearing Florida tag# M4981Q parked in the garage of the above residence with the garage door standing completely open. The Ford had what appeared to be dryer vent piping that was attached to the Ford's exhaust pipe at the rear of the vehicle that went into the trunk of the vehicle. It was also observed that the passenger side of the rear seat was folded down.</p>

Upon further investigation Deputy Jacob observed a white male, identified as Bruce Haughton in the driver's seat and a white female, identified as Katherine Goddard in the passenger seat. Both seats were reclined back and Bruce had a pulse and was breathing. Deputy Jacob then checked the status of Katherine and she was unresponsive with no vital signs. The garage had a slight odor of exhaust fumes and the garage door that leads into the residence had some remaining duct tape around the edges as if it was sealed off from the garage side. Also, an apparent suicide note was located on the rear trunk area of the exterior of the vehicle.

Upon my arrival on scene I spoke with Raquel Schlenvoigt who advised that her mother is Bi-polar and has been off her medication for approximately two (2) weeks. Bruce and Katherine had recently got cut off from their pain pills that they received regularly, according to Raquel. Bruce and Katherine were planning on moving to New Hampshire to live with Katherine's parents. Katherine was advised recently that Bruce was not welcome to the assistance that was going to be provided by Katherine's family in New Hampshire.

On July 26 at approximately 1224 hours contact was made with Bruce at Rymfire Park in Palm Coast in order to get a consent for medical records release signed. Bruce had stated he wanted me to look at his medical records to see the carbon dioxide levels. The form had to be completed in order to obtain those records. During this encounter we discussed Bruce's statement from the day prior (July 25, 2017.) Additionally, Bruce stated that he didn't know what the suicide note stated but knew she had a note that was going to be left. Bruce stated the vehicle had battery issues and the transmission would slip in second gear but that was the only thing wrong with the vehicle. Bruce advised that when they attempted to end their lives on Thursday (June 29, 2017) the car started to die on them because Bruce "assumes lack of oxygen" in the garage. Katherine and Bruce went to Walgreens on Thursday night, at approximately midnight, to get sleeping pills. When Bruce and Katherine attempted to end their lives on Thursday they used a garden hose with a rolled up cloth in the tail pipe. Bruce stated that this is where we will find finger prints because Katherine could not get the duct tape to peel easily so Bruce assisted. Bruce recalled pressing the tape in place against the door (garage entry door) seal across the top. Bruce stated that Katherine tried to set the dryer vent on the tail pipe but Bruce secured it because Katherine was unable to. Bruce stated he used a pair of pliers to help secure the dryer vent. On Thursday when their plan was unsuccessful Bruce stated he had to think of a different way to accomplish the task and that's when he thought of a bigger hose. According to Bruce there was discussion on ways that's they could carry out their plan better which they thought about using a gun. Bruce advised that Katherine wasn't set on using the gun however he had no problem using one. Bruce put the gun on Katherine's side of the vehicle so it would be easier for him to access. Bruce was asked looking back on the situation would he have done anything to prevent it like talking her out of it and Bruce stated he would. Bruce also advised that he would not have attempted to harm himself if it was just him and Katherine wasn't involved. Katherine had made mention of killing herself and Bruce responded to Katherine by stating "ok let's do it." Bruce stated that he has no guilt for the situation other than not dying with her.

Medical records received show Bruce's carboxyhemoglobin level at 3%, which was taken on June 30, 2017 at 2221 hours.

Bruce was arrested for assisting Katherine in self-murder.
