On November 21, 2010 at approximately 1759 hours I was dispatched to 5 Florida Park Drive in reference to a physical disturbance. Upon arrival I made contact with Scott Beat who advised that a male named Edward Herrera just assaulted him and left the area.

Scott advised that he was at his office and heard a knock on his back door. He advised that he answered the door and it was Edward. He advised that as soon as he opened the door Edward punched him in the face. He advised that Edward advised him to stop sleeping with his wife. Scott advised that an altercation took place and they were on the ground physically fighting. Scott advised that when the altercation ended Edward walked back to his vehicle and advised Scott that the altercation had to end because his [REDACTED] daughter was in the car. He opened the door to show Scott she was present. Scott's eye was black and blue and swollen. He had a laceration to his upper lip that was bleeding while on scene. He had multiple scrapes to his back and side. He was complaining of rib pain and jaw pain. Medical units arrived and he refused attention at the scene. He went to the hospital for medical attention.

Michelle Herrera was on scene at Scott's office upon the arrival of law enforcement. She advised that after the incident took place her daughter contacted her and advised her she was scared. Her daughters name is [REDACTED] [REDACTED] advised Michelle that they were on there way to Daytona to pick up Edward's mother. Michelle advised that she was not at Scott's office when her husband arrived.

Edward was contacted at his residence at approximately 1931 hours. I made contact with him at approximately 2027 hours at which time he was advised of Miranda Rights. He advised he understood and that he was willing to speak about the incident. Edward advised that he had his daughter in his vehicle and they were on their way to his office. He advised that he turned into a parking lot of a two story building. He advised he drove around back and observed his wife's vehicle sitting there. He then observed Scott's motorcycle sitting at the back of his office. He advised that he went to the door and knocked and didn't get an answer at the door. He advised that he continued knocking until Scott answered the door. Edward advised that he wanted to talk to his wife. Edward advised that Scott advised him she wasn't there. He advised that Scott took a swing at him and "grazed" just under his right lip causing a small scrape. He advised that an altercation then took place. He advised that he was on top of Scott on the ground. He advised that he advised Scott that the altercation was over and that he was going to let him up. Once they got up Edward advised that he started walking towards his vehicle. He advised Scott followed him continuing to argue with him. He advised Scott that the fight was over and they couldn't fight anymore due to his daughter being in the vehicle. He advised he opened the car door to show Scott that his daughter was there. He advised he then left the scene and was going to contact law enforcement later because he didn't want his daughter to witness anything.

Edward was placed into custody for battery. He was transported to the inmate facility without incident. Edward and Scott provided written statements about the incident.

Edward sustained a small scrape under his lip on the right side. He had few lacerations on the top of his head and on the arm. Scott sustained a swollen and black and blue eye, a laceration to the left side of his lip and multiple scrapes to his back and sides. He was also complaining of his ribs and jaw hurting. The hospital advised that there didn't appear to be any serious injuries at this time. Deputy Moore took pictures of both Edward and Scott's injuries. No further information at this time.
