CHANGING EMPLOYMENT WITHOUT PERMISSION

Violation of Condition (3) of the Order of Probation, by changing his employment without first procuring the consent of the probation officer, and as grounds for belief that the offender violated his probation, Officer Heidi Spence states that on or about May 19, 2022, the offender did obtain a second job at San Diego Grill located at 5535 South Williamson Boulevard, Suite# 656, Port Orange, Florida 32128 without the consent of the probation officer, as told to Officer Heidi Spence on May 27, 2022, by the offender and then verified by Clint, kitchen manager at the restaurant on May 27, 2022.

LEAVING THE COUNTY WITHOUT PERMISSION

Violation of Condition (3) of the Order of Probation, by leaving his county of residence without first procuring the consent of the probation officer, and as grounds for belief that the offender violated his probation, Officer Heidi Spence states that on May 24, 2022, the offender did leave Flagler County, Florida, his county of residence, without the consent of the probation officer and did enter Volusia County, Florida, as told to Officer Heidi Spence on May 27, 2022, by the offender and then verified by Clint, kitchen manager at the restaurant on May 27, 2022.

FAILURE TO PAY COURT COSTS

Violation of Condition (10) of the Order of Probation, by failing to make court cost payments to the probation officer as directed in accordance with the payment instructions of the court, and as grounds for belief that the offender violated his probation, Officer Heidi Spence states the offender is \$798.12 in arrears, as of May 27, 2022.

FAILURE TO PAY FOR DRUG TEST FEE

Violation of Condition (11) of the Order of Probation, by failing to pay for drug test fees, and as grounds for belief that the offender violated his probation, Officer Heidi Spence states that the offender is \$67.60 in arrears as of May 27, 2022.

FAILURE TO COMPLETE PUBLIC SERVICE HOURS

Violation of Special Condition (8) of the Order of Probation, by failing to complete public service hours, at an approved location, as directed by the probation officer, and as grounds for belief that the offender violated his probation, Officer Heidi Spence states that the offender was instructed on April 4, 2018 and on September 8, 2020 to complete 100 public service hours ordered during the supervision period. The offender did not complete the required public service hours as of May 27, 2022.
