(Property owners in the Army Corps Project who have not acted to sign an easement for dune restoration)

EXPLANATION OF SPREADSHEET

- Property owners are listed from north to south in sequence on the attached spreadsheet.
- Parcel numbers and property owners are individually identified, including the assessed value of the dune remnant.
- There is a category for special notes which identifies the physical location of the dune remnant according to the street address on South Oceanshore Boulevard.
- The notes also indicate if the individual owns only a remnant and, if so, the property on the west side of the street is identified as a reference point, including its ownership based on records of the Property Appraiser.
- The notes further show the year of remnant purchase.
