driving a blue 2002 Ford Crown Victoria, bearing a Florida tag of DVAV29, westbound on State Road 100. I observed Holloway's vehicle weaving in his lane of travel in a manner that is consistent with the driver being ill, fatigued or impaired. I observed Holloway vehicle cross the lane markers and he drove on the shoulder of the road way. I activated my emergency lights to conduct a traffic stop in reference to checking his welfare for his safety and the safety of everybody else on the roadway as well as the violation of the lane marker. Holloway was slow to respond. I conducted the traffic stop in the parking lot at State Road 100 and Old King Road.

As I approached Holloway I detected the strong odor of an alcoholic beverage coming from him and the odor got stronger as he spoke. Holloway's eyes were watery and bloodshot. Holloway's face was

flushed. Holloway's speech was mumbled at times. Holloway was slow to respond to my request. Holloway stated that he drank a beer or two. I positively identified Holloway with his Florida Driver License.

As Holloway exited the vehicle he was unsteady on his feet. I advised Holloway that I was conducting a criminal investigation for driving under the influence and he indicated that he understood. I advised Holloway of the Miranda warning, via card, and he indicated that he understood his rights. Holloway stated that he only drank one beer. As I was talking to Holloway I continued to detect the strong odor of an alcoholic beverage coming from his breath.

I requested that Holloway conduct field sobriety exercises and he complied. Holloway displayed signs of impairment as he conducted the field sobriety exercises (see Field Sobriety Report and video).

I asked Holloway to rate himself on a scale of 1 to 10 (1 being sober and 10 being fall down drunk). Holloway rated himself a, "3". Holloway thought he was ok to drive. Holloway stated that he drank 2 to 3 beers.

I advised Holloway that he was being arrested for Driving Under the Influence and I placed him in handcuffs.

Holloway agreed to submit to a breath test. Holloway provided two breath samples that indicated that his BAC was .116 and .109.
