

COUNT I: JOSEPH THOMAS HOROVSKY on or between May 1, 2022, and September 1, 2022, in the County of FLAGLER and State of Florida, JOSEPH THOMAS HOROVSKY, a person 18 years of age or older, did unlawfully and intentionally touch L.G., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice L.G. to so touch L.G., in that JOSEPH THOMAS HOROVSKY did touch the genitals and/or genital area and/or clothing covering the genitals or genital area of L.G., contrary to Florida Statute 800.04(5)(b). (LIFE FEL)

COUNT II: IN THAT JOSEPH THOMAS HOROVSKY on or between October 21, 2019, and March 13, 2021, in the County of FLAGLER and State of Florida, JOSEPH THOMAS HOROVSKY, a person less than 18 years of age, did unlawfully and intentionally touch L.G., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice L.G. to so touch JOSEPH THOMAS HOROVSKY, in that JOSEPH THOMAS HOROVSKY did touch the genitals and/or genital area and/or clothing covering the genitals or genital area of L.G, contrary to Florida Statute 800.04(5)(c)1. (2 DEG FEL)

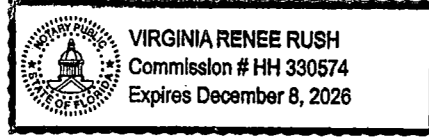
