

### ORDER OF MODIFICATION OF PROBATION

THIS CAUSE was considered due to a violation brought before the court to modify the terms of **Probation** which was ordered on **February 17, 2017** by Circuit Judge **Matthew Foxman** for a term of **Ten (10) Years**, in accordance with Florida Law. Having given due consideration, **Probation** is modified in accordance with Section 948.03 Florida Statutes, in the following manner:

- Your supervision is Modified to Twelve (12) Months Community Control with Drug Offender Conditions followed by the remainder of Probation with Drug Offender Conditions.  
YOU WILL COMPLY WITH THE FOLLOWING CONDITIONS OF COMMUNITY CONTROL, IN ADDITION TO THE STANDARD CONDITIONS AND ANY OTHER SPECIAL CONDITIONS ORDERED BY THE COURT:  
(15) You will report to your officer as directed, at least one time a week, unless you have written consent otherwise.  
(16) You will remain confined to your approved residence except for one half hour before and after your approved employment, public service work, or any other special activities approved by your officer.  
(17) You will maintain an hourly accounting of all your activities on a daily log, which you will submit to your officer on request.  
YOU WILL COMPLY WITH THE FOLLOWING CONDITIONS OF DRUG OFFENDER PROBATION, IN ADDITION TO THE STANDARD CONDITIONS AND ANY OTHER SPECIAL CONDITIONS ORDERED BY THE COURT.  
You will participate in a specialized drug treatment program, either as an in-patient or out patient, as recommended by the treatment provider. You will attend all counseling sessions, submit to random urinalysis and, if an in-patient, you will comply with all operating rules, regulations and procedures of the treatment facility. You will pay for all costs associated with treatment and testing unless otherwise directed.  
Additional instructions ordered:  
a) You must undergo a Drug and Alcohol evaluation and, if treatment is deemed necessary, you must successfully complete the treatment, and be responsible for the payment of any costs incurred while receiving said evaluation and treatment, unless waived by the court.  
b) You will abstain entirely from the use of alcohol and/or illegal drugs, and you will not associate with anyone who is illegally using drugs or consuming alcohol.  
c) You will submit to urinalysis testing on a monthly basis to determine the presence of alcohol or illegal drugs. You will be required to pay for the tests unless exempt by the court.  
d) You will not visit any establishment where the primary business is the sale and dispensing of alcoholic beverages.

It is further ORDERED that the clerk of court file this order in the official records and provide certified copies to the officer for use in compliance with the requirements of the law.
