Committed criminal mischief by spraying the victim's light pole and camera with her garden hose over several months and dates. This action caused the camera and light to short out and need to be replaced.

I contacted the victim on July 20, 2023, referencing ongoing criminal mischief. The victim advised that he has had issues with the defendant and has video of her spraying his light pole/camera (6) six times from December 2022 through May 2023. The Victim also said he had printed receipts for \$134.43 for the damage caused by the defendant's actions.

On July 13, 2023 (case number 2023-00015544), Captain Blanchette spoke with the Defendant about their ongoing neighbor dispute. While Captain Blanchette talked to the defendant at her home, the defendant admitted to spraying the light and cameras (axon video time-stamped 10:44:30 a.m.).

On July 24, 2023, I responded to the Victim's home, where he had completed a (5) five-page sworn statement, had several pictures of the damage, and receipts for the replacements. The Victim also had a USB drive with video of the Defendant spraying the light/cameras. Based on the videos, the timeline is as follows:

12-12-2023 Defendant spraying light/camera
01-19-2023 Defendant spraying light/camera
01-22-2023 Defendant spraying light/camera
01-31-2023 Defendant spraying light/camera
02-01-2023 Defendant spraying light/camera
05-14-2023 Defendant spraying light/camera

The USB drive was logged into evidence, and the statement and printed pictures were attached to the report.
