and lights over the course of several months, destroying the cameras. This incident is document under case number 23-16218. Deputy Chief Blanchette also spoke with Kerri on 7/13, at which time Kerri admitted to spraying the light and cameras in order to damage them; Kerri never denies her destructive acts nor the malicious intent behind them, yet also routinely fails to demonstrate or expresses remorse.

Upon my arrival today, I made contact with James and his wife, Debra, in her their living room. James advised the following:

Just before he called for law enforcement, Kerri had entered his front yard on foot. She stomped around the yard yelling and screaming, then began throwing rocks at the east side of the Nardone's residence, striking the wall repeatedly and making a loud sound. This frightened Debra, who begged James not to go outside. Kerri then walked into view of another one of James' cameras in the front yard area, and began throwing rocks at this camera, a Reolink 4k security camera mounted on a pole.

James showed me the surveillance footage on his computer.

The footage shows Kerri stomping aggressively onto James' property. Kerri can be seen walking out of the camera range, then from out of view she begins hurling rocks at the side of the Nardone's house. At this time, Kerri was on her own property, on the other side of a privacy fence; Kerri herself cannot be seen in the video footage, although the sounds of rocks hitting the wall can be plainly heard. James took me outside and showed me the side of the house where two (2) cameras are mounted high on the wall, out of Kerri's reach. It did not appear she had damaged these cameras, although it was difficult to tell in the dark. However, debris was scattered around the area, included a shattered ceramic Mother Mary figurine that Kerri later admitted to throwing, as well as numerous golfball-sized rocks, shampoo bottles, and a bra.

Kerri can then be seen walking into view of one of James' cameras on the front (south-facing) side of the house, where she begins yelling and throwing rocks toward the lens of the camera. She does this several times, repeatedly making contact with the camera. Throughout this display, Kerri can be heard screaming profanity. Finally, she yells, "I'm sure the cops will be here soon, but one more time," then she hurls another rock at the camera, making a loud cracking sound. This camera, the Reolink 4k security camera, was mounted on a pole. I observed it later, and noted that the lens was obviously destroyed from

Kerri's onslaught.

Both Debra and James completed sworn, written statements.

The relevant portion of Debra's statement reads as follows, edited lightly for clarity:

At approximately 7:30 pm on 9/11/23 my neighbor, Kerri Huckabee, started pounding on our front door. Due to many other verbal assaults by Kerri and family, we did not open the door. She was yelling and screaming at our house. She then proceeded to throw rocks at the east side of our house that faces her house. She was aiming at our surveillance cameras. While pelting the house she continued to verbally assault us.

The relevant portion of James' statement reads as follows, also edited lightly for clarity:

Between the hours of 7:30 pm and 8 pm, Kerri Huckabee was running around my house throwing rocks at surveillance cameras.

James advised that he wished to pursue charges against Kerri for throwing rocks at his house and cameras, and causing extensive damage to his Reolink surveillance camera, as well as unknown damage to his house siding and other cameras; James will inspect his house and cameras in the daylight to determine further damage. James completed an Affidavit of Prosecution, and was issued a Victim's Rights/Remedies pamphlet, which he signed for. He did not wish to invoke his right to confidentiality pursuant to Marsy's Law.

I sent James an Axon Citizen Capture link, which he will use to upload all videos of Kerri attacking/damaging his cameras and residence; these videos will then be tagged on Evidence.com.

While I was speaking to the Nardones inside, Kerri began banging on the front door again. I asked that the Nardones stay inside while I and Ofc. Nobre made contact with Kerri. I located Kerri in the front yard of her residence. She was still stomping around and yelling. Her attitude was belligerent, hostile, and erratic. She later admitted to having consumed a single glass of wine, as well as Kava tea.

I never questioned Kerri, but she made numerous spontaneous utterances admitting to having intentionally thrown stones at the Nardone's house and cameras; however, she stated she did not care and felt the Nardones deserved to have their house assaulted and their property destroyed. At one point she shouted, "Did I throw stuff? Yes. I threw my Mother Mary, which was my mom's. I threw my shampoo, I did everything!"

I attempted to have a rational, information-gathering conversation with Kerri, which I quickly realized would be impossible due to her heightened emotional state and her habit of stomping around wildly as I tried to speak with her. Kerri continued to insist that the Nardones' cameras were somehow unlawful or filming her covertly, although officers have on several occasions observed the cameras and footage and have repeatedly advised Kerri that they are not in violation of any law.

I therefore told Kerri, "You cannot respond to something that you perceive as a wrong, by committing crimes in response." Kerri became increasingly agitated and replied, "Dude, you're not making any sense."

At this time, I attempted to secure Kerri in hand restraints.

Kerri immediately tensed her arms and pulled away from me. She continued yelling, and yanking her arms away. She screamed, "Let go of my fucking hands." Kerri then lifted her leg in a deliberate motion and kicked me in the thigh. Kerri continued to aggressively fight my and Ofc. Nobre's lawful attempts to detain her. Kerri kicked Ofc. Nobre in the shin, and later kicked me a second time in the upper leg as I attempted to place her in my patrol vehicle. Kerri's actions were intentional and willful, not the inadvertent flailings of an actively resisting subject.

Ultimately, I placed Kerri under arrest in reference to the following criminal charges:

**Criminal Mischief, in violation of F.S.S. 806.13.1.B.1; to wit:**

Kerri willfully and maliciously damaged James' property, a Reolink surveillance camera, by repeatedly throwing stones and other hard items at the camera while loudly yelling about her intent to destroy it. I could clearly see a pronounced crack in the camera lens, even at night and from approximately six feet

away. This camera will need to be replaced, and the cost to do so is approximately \$150.

**Throwing a Deadly Missile, in violation of F.S.S. 790.19; to wit:**

Kerri hurled multiple stones, as well as a ceramic figurine, at James Nardone's residence. At this time, James and his wife, Debra Nardone, were inside the residence, afraid for their safety. This act was done wantonly and maliciously, in an attempt to damage James' security cameras. Note that two (2) of the cameras Kerri targeted with her assault were attached to the residence; the rocks could be plainly heard striking the side of the house.

**Resisting an Officer with Violence (2X), in violation of F.S.S. 843.01; to wit:**

Kerri knowingly and willfully resisted my attempts to secure her in hand restraints by aggressively and violently kicking both myself and my partner, Ofc. Nobre. These kicks were directed toward our legs, and were performed intentionally and maliciously. Kerri also stiffened her arms and repeatedly wrenched away from me while screaming at a loud volume. At this time, I was attempting to place Kerri under arrest for Criminal Mischief and Throwing a Deadly Missile.

Kerri was then secured in my patrol vehicle. She claimed to be experiencing pain in various areas of her body, and I offered to have EMS respond to evaluate her. Kerri found this humorous and declined. Shortly afterward, I transported Kerri to the FCIF without incident.
