RE: Reported Incident at Flagler County Courthouse

On November 29th 2017, I was approached by Flagler County Circuit Judge Dennis Craig and asked to step in his office. We sat down and he discussed an alleged incident that was told to him by Flagler County Civil Judge R. Lee Smith. The alleged incident was that Deputy Jeff Puritis who is a Bailiff for Judge Dennis Craig had sent an inappropriate picture to Judge R. Lee Smith's Judicial Assistant Kenley Matejka. Judge Dennis Craig said the picture was also seen and confirmed by Judge R. Lee Smith.

After this information was forwarded to me I met with Judicial Assistant Kenley Matejka. I asked her about the alleged incident. She informed me that Deputy Jeff Puritis had sent her an inappropriate picture. I asked to see the picture and the phone number it came from. The phone number was which is confirmed to be Deputy Jeff Puritis's cell phone. The picture was of a woman sitting on a couch wearing see-through negligee where her breasts and nipples could be seen. The text was sent on September 28th 2017 at 1:44 P.M. After the photo was sent there was no dialogue or mention about it from either party, nor was there a message sent with it. Kenley Matejka stated that they have known each other for two and a half years, and they do text from time to time.

Kenley Matejka stated that she did not want to make a formal complaint at this time, and did not want to see Deputy Puritis get fired, but was offended by the picture.

Deputy Puritis is in violation of FCSO General Order 020 Standards of Conduct regarding Courtesy and Respect which is a category one violation. The proposed recommended discipline for a category one infraction is a written reprimand.

I then informed Judge Dennis Craig of the information gathered on the incident and he agreed with the resolution.
