SPECIFICATIONS OF CHARGES:


COUNT I: IN THAT DOROTHY CALISTA SINGER on or between February 8, 2017 and April 7, 2017, in the County of FLAGLER and State of Florida, did unlawfully kill and murder CHARLES WILLIAM SINGER, a human being, by shooting him with a firearm; and did perpetuate said killing from a premeditated design to effect the death of CHARLES WILLIAM SINGER; and while in the commission of said offense did actually possess and use a firearm, and did carry, display, use, threaten to use, or attempt to use a weapon or firearm; and did discharge a firearm, causing death or great bodily harm, contrary to Florida Statutes 782.04(1) and 775.087(1)&(2). (CAPITAL FEL)


