The Fall Term Grand Jury, in and for FLAGLER County, Florida, empaneled and sworn to inquire and true presentment make, hereby, in the name of and by the authority of the State of Florida, brings this prosecution and makes the following charge or charges in ELEVEN counts:

CHARGE(S):

COUNT 1: SEXUAL BATTERY ON PERSON LESS THAN 12 YEARS OF AGE

COUNT 2: SEX BATTERY; ENGAGE SEX CONDUCT, MINOR 12 TO 18 YEARS BY PERSON IN FAMILIAL OR CUSTODIAL AUTHORITY

COUNT 3 LEWD/LASCIVIOUS MOLEST PRSN 18 YOA/OLDER ON A PERSON 12YO OR OLDER BUT LESS THAN 16YO

COUNT 4: SEXUAL BATTERY ON PERSON LESS THAN 12 YEARS OF AGE (DIRECT)

COUNT 5: SEXUAL BATTERY ON PERSON LESS THAN 12 YEARS OF AGE (DIRECT)

COUNT 6: SEX BATTERY; ENGAGE SEX CONDUCT, MINOR 12 TO 18 YEARS BY PERSON IN FAMILIAL OR CUSTODIAL AUTHORITY (DIRECT)

COUNT 7: SEX BATTERY; ENGAGE SEX CONDUCT, MINOR 12 TO 18 YEARS BY PERSON IN FAMILIAL OR CUSTODIAL AUTHORITY (DIRECT)

SPECIFICATIONS OF CHARGE: COUNT 1: On or between August 18, 2022, and August 17, 2024, KRISTOPHER HENRIQSON in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person eighteen years of age or older, did unlawfully commit sexual battery upon , or injure the sexual organs during an attempt to commit sexual battery upon A.L., a person less than twelve years of age, by KRISTOPHER HENRIQSON's penis did penetrate the mouth of A.L., contrary to Florida Statute 794.011(2)(a). (CAPITAL FELONY)(LEVEL 10)

SPECIFICATIONS OF CHARGE: COUNT 2: On or between August 18, 2024, and February 10, 2025, KRISTOPHER HENRIQSON in the County of FLAGLER and State of Florida, did unlawfully engage in sexual activity with A.L., a child 12 years of age or older but less than 18 years of age, while KRISTOPHER HENRIQSON was in a position of familial or custodial authority over A.L., by KRISTOPHER HENRIQSON's penis did penetrate the mouth of A.L. contrary to Florida Statute 794.011(8)(b). (1 DEG PBL FEL)

SPECIFICATIONS OF CHARGE: COUNT 3: On or about February 10, 2025, in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person 18 years of age or older, did unlawfully and intentionally touch A.L., a person 12 years of age or older, but less than 16 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice A.L. to so touch KRISTOPHER HENRIQSON, in that KRISTOPHER HENRIQSON did touch A.L.'s breast(s) or the clothing covering A.L.'s breast(s), contrary to Florida Statute 800.04(5)(c). (2 DEG FEL),

SPECIFICATIONS OF CHARGE: COUNT 4: On or between August 18, 2022, and August 17, 2023, KRISTOPHER HENRIQSON in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person eighteen years of age or older, did unlawfully commit sexual battery upon , or injure the sexual organs during an attempt to commit sexual battery upon A.L., a person

less than twelve years of age, by KRISTOPHER HENRIQSON's penis did penetrate or have union with the anus of A.L., contrary to Florida Statute 794.011(2)(a). (CAPITAL FELONY)(LEVEL 10)

SPECIFICATIONS OF CHARGE: COUNT 5: On or between August 18, 2023, and August 17, 2024, KRISTOPHER HENRIQSON in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person eighteen years of age or older, did unlawfully commit sexual battery upon , or injure the sexual organs during an attempt to commit sexual battery upon A.L., a person less than twelve years of age, by KRISTOPHER HENRIQSON's penis did penetrate or have union with the female genitals of A.L., contrary to Florida Statute 794.011(2)(a). (CAPITAL FELONY)(LEVEL 10)

SPECIFICATIONS OF CHARGE: COUNT 6: On or between August 18, 2024, and February 7, 2025, KRISTOPHER HENRIQSON in the County of FLAGLER and State of Florida, did unlawfully engage in sexual activity with A.L., a child 12 years of age or older but less than 18 years of age, while KRISTOPHER HENRIQSON was in a position of familial or custodial authority over A.L., by KRISTOPHER HENRIQSON's penis did penetrate or have union with the female genitals of A.L. contrary to Florida Statute 794.011(8)(b). (1 DEG PBL FEL)


SPECIFICATIONS OF CHARGE: COUNT 7: On or between August 18, 2024, and February 10, 2025, KRISTOPHER HENRIQSON in the County of FLAGLER and State of Florida, did unlawfully engage in sexual activity with A.L., a child 12 years of age or older but less than 18 years of age, while KRISTOPHER HENRIQSON was in a position of familial or custodial authority over A.L., by KRISTOPHER HENRIQSON's finger(s) did penetrate the female genitals of A.L. contrary to Florida Statute 794.011(8)(b). (1 DEG PBL FEL)

SPECIFICATIONS OF CHARGE: COUNT 8: On or between August 18, 2022, and August 17, 2024, in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person 18 years of age or older, did unlawfully and intentionally touch A.L., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice A.L. to so touch A.L., in that KRISTOPHER HENRIQSON did touch the buttocks or the clothing covering the buttocks of A.L., contrary to Florida Statute 800.04(5)(b). (LIFE FEL)


SPECIFICATIONS OF CHARGE: COUNT 9: On or between August 18, 2022, and August 17, 2024, in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person 18 years of age or older, did unlawfully and intentionally touch A.L., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice A.L. to so touch A.L., in that KRISTOPHER HENRIQSON did touch the female genitals or the clothing covering the female genitals of A.L., contrary to Florida Statute 800.04(5)(b). (LIFE FEL)

SPECIFICATIONS OF CHARGE: COUNT 10: On or between August 18, 2022, and August 17, 2024, in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person 18 years of age or older, did unlawfully and intentionally touch A.L., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice A.L. to so touch A.L., in that KRISTOPHER HENRIQSON did touch the breasts or clothing covering the breasts of A.L., contrary to Florida Statute 800.04(5)(b). (LIFE FEL)

SPECIFICATIONS OF CHARGE: COUNT 11: On or between August 18, 2022, and August 17, 2024, in the County of FLAGLER and State of Florida, KRISTOPHER HENRIQSON, a person 18 years of age or older, did unlawfully and intentionally touch A.L., a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them {or} did force or entice A.L. to so touch A.L., in that KRISTOPHER HENRIQSON did force or entice A.L. to touch KRISTOPHER HENRIQSON's penis with A.L.'s hand, contrary to Florida Statute 800.04(5)(b). (LIFE FEL)


