
COUNT 2: 794.011 2A - SEXUAL BATTERY ON PERSON LESS THAN 12 YEARS OF AGE

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT 1: On or between August 1, 2006, and May 31, 2009, in the County of FLAGLER and State of Florida, KERMIT CARL BOOTH, a person eighteen years of age or older, did unlawfully commit sexual battery upon S.L., or injure the sexual organs during an attempt to commit sexual battery upon S.L., a person less than twelve years of age, by KERMIT CARL BOOTH's penis did have union with or penetrate the mouth of S.L. contrary to Florida Statute 794.011(2)(a). (CAP FEL)(LEVEL 10)

COUNT 2: On or between August 1, 2006, and May 31, 2009, in the County of FLAGLER and State of Florida, KERMIT CARL BOOTH, a person eighteen years of age or older, did unlawfully commit sexual battery upon S.L., or injure the sexual organs during an attempt to commit sexual battery upon S.L., a person less than twelve years of age, by KERMIT CARL BOOTH did put his mouth on the vagina of S.L., contrary to Florida Statute 794.011(2)(a). (CAP FEL)(LEVEL 10)


