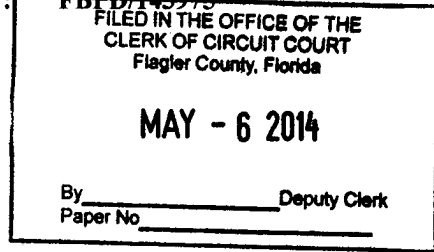

CHARGE(S):

- I) DISORDERLY CONDUCT
- II) BATTERY

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: VASSILI NIKOLAEVICH MIRONOV, on or about March 19, 2014, in the County of FLAGLER and State of Florida, unlawfully did commit such acts as are of a nature to corrupt the public morals or outrage the sense of public decency, or affect the peace and quiet of persons who may witness them, or engage in brawling or fighting, or engaged in conduct constituting a breach of the peace or disorderly conduct, contrary to Florida Statute 877.03. (2 DEG MISD)

COUNT II: IN THAT VASSILI NIKOLAEVICH MIRONOV on or about March 19, 2014, in the County of FLAGLER and State of Florida, did actually and intentionally touch or strike RALPH MICHAEL ORTIZ, against the will of RALPH MICHAEL ORTIZ {or} did intentionally cause bodily harm to RALPH MICHAEL ORTIZ, contrary to Florida Statute 784.03(1)(a) . (1 DEG MISD)
