NARRATIVE

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 5th day of July, 2003, at approximately 0250 a.m. at Palm Coast Pkwy. Northbound I-95 Exit Ramp #209 within FLAGLER County, violated the law and did then and there:

INTENTIONALLY AND UNLAWFULLY THREATENED BY ACT TO DO VIOLENCE TO A LAW ENFORCEMENT OFFICER, EQUIPPED WITH AN APPARENT ABILITY (DEADLY WEAPON - MOTOR VEHICLE) TO DO SO, AND DOING SOME ACT WHICH CREATED A WELL-FOUNDED FEAR THAT SUCH VIOLENCE WAS IMMINENT.
