reluctant to report these letters being placed in her mailbox until she received one filled with a white powdery substance on July 31, 2023. [REDACTED] stated that she is familiar with Jason's handwriting, and stated that the letter's are Jason's handwriting.

[REDACTED] advised the letter was filled with the white powdery substance and in the letter it stated, "heart attacks happen". [REDACTED] became concerned for her safety and did not know if this was meant to be a threat or to harm her. [REDACTED] advised she has been receiving letters from Jason for years and recognized his handwriting. [REDACTED] stated these letters have been on going for many years but this was the first time she received one with anything inside of it.

[REDACTED] advised Jason has not lived in the home for approximately a year and a half. [REDACTED] stated she has legally been divorced from Jason since February or March of 2023, and has had no contact with him for approximately a year and a half. [REDACTED] stated Jason was made aware that she had applied for an injunction through the Flagler County Courthouse at one point during their divorce and Jason understood [REDACTED] no longer wanted contact with him after the divorce.

[REDACTED] and Jason have two children in common, but Jason does not have any contact with the children. [REDACTED] stated that in the divorce and child custody agreement, Jason is allowed to write letters to the children but none of the letters she has received were intended or addressed to her children. [REDACTED] went on to state that Jason has not made any attempt to contact their children since he has moved out of the home.

[REDACTED] stated that the letters come typically once a week from Jason. [REDACTED] has a Blink surveillance camera that views the mailbox. [REDACTED] stated the camera does not save the video recordings because she does not have a subscription. [REDACTED] stated the Ring camera at her front door does not pick up motion at the mailbox.

[REDACTED] advised while going through her bedroom recently she noticed the smoke detector in her room did not look normal. [REDACTED] stated when she took it down to inspect it further and she could see a camera in it. [REDACTED] also found a camera next to her bed that looked like a wall charger, and a small compartment in her closet. [REDACTED] showed me the compartment in her closet which featured a door that when she had initially opened contained more letters, sticky notes, sex toys and condoms. [REDACTED] advised she was not aware the compartment was there or where these items came from.

[REDACTED] stated she has been in emotional distress from the letters and finding the cameras in her home. [REDACTED] advised Jason does not have any legitimate purpose or reason to be at the residence or contacting her. [REDACTED]

stated finding the letter with a white powdery substance put her in fear for her safety and she felt as though it could have been with intent to scare or poison her. [REDACTED] stated she did not know what else to do at this point and began to cry. [REDACTED] stated she wanted to pursue criminal charges against Jason.

[REDACTED] completed a sworn written statement, Marsy's Law form, and was given a Domestic Violence Victim's Rights brochure. [REDACTED] turned over all letters and cameras to me to be submitted into evidence.

It should be noted that I asked [REDACTED] about WiFi in the home and if she changed the password to ensure Jason cannot access the WiFi. [REDACTED] advised she has not. Jason is also a known violent offender in FCIC/NCIC.

All letters and cameras were submitted into Evidence. Due to the unknown white powdery substance inside the envelope and Jason's history with his handling of explosive materials, the letter was not read or opened. The other letters were also submitted but were not read due to the volume of letters. All paperwork will be submitted into the Records Division.

Based on the fact that Jason has participated in a course of conduct directed at [REDACTED] which has caused substantial emotional distress to her, serving no legitimate purpose, specifically leaving letters and notes at her residence that serve no purpose, for an extended period of time, and lastly leaving a note covered in an unknown powder, stating that "heart attacks happen", which placed the victim in a well founded fear that Jason was attempting to harm or poison her, and the fact that Jason and [REDACTED] were married, previously lived together, and have children in common, probable cause exists that Jason did commit the crime of Stalking, as described by Florida State Statute 784.048(2) which is a crime listed under Domestic Violence Florida State Statute 741.28(2)(3).

On August 2, 2023, at approximately 2223 hours, I attempted to locate Jason at his residence, listed as 9 Bronson Lane, Palm Coast. Jason was located and arrested for Stalking (Domestic Violence).

Jason was transported to the Flagler County Inmate Facility without incident.
