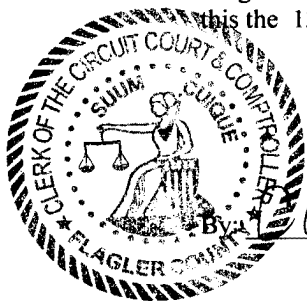

the juvenile and pulled the juveniles pants/underwear down and touched his genitals. C.R advised he was able to break free and ran to the parking lot and called law enforcement. Later, C.R called his parents and they came to the scene

I searched the area in where C.R stated he encountered the suspect. While I was walking the wooded path, I made contact with an individual, later to be identified as Jason Stockwell (suspect) who matched the description given by C.R and also another individual (Ronald Bullen-witness). C.R. was brought to the suspect and did positively identify Jason Stockwell as the person he had the encounter with in the woods, however stated that he never saw the other individual (Ronald Bullen)

I then spoke with Ronald who stated that he was sitting inside his truck in the Graham Swamp parking lot. Ronald went on to say that he observed a red vehicle (FL Tag-525HHP) pull up and a man exited the vehicle and began walking down the path. Ronald then stated he saw another individual (C.R) start walking behind him (Jason Stockwell). Ronald said it appeared in the individual (C.R) was following the other person (Jason Stockwell); however was walking 6-10 feet behind him. Ronald then stated that he lost sight of the two individuals and later encountered Jason walking by himself on the trail.

Jason was then transported to CID for questioning and denied the allegation, but did give statements that were conflicting with the victim's statement. Jason was then taken into custody reference FSS 800.04(5) (C) (2) Lewd or Lascivious Molestation Offender over 18, victim 12-16 and was transported to the Flagler County Inmate Facility without incident.

To be noted, this area of Graham Swamp has been a problematic area involving anonymous males meeting and engaging in sexual encounters.

C.R. has been referred to the Children's Advocacy Center to complete a more detailed statement.
