The victim, Yolonda Williams, had numerous lacerations in the form of stab marks, from which she was bleeding profusely. The suspect, Jermaine Williams, was lying on the ground and had blood on his pants and other clothing. After the preliminary response, the residence was cleared, and the crime scene area was secured. Law enforcement officers began to interview witnesses.

Witness one stated she heard screaming while walking westbound on Dr. M.L.K Blvd at the intersection of S. Pine Street.

Witness two stated he was walking down S. Pine Street when he saw two people on the road. The female victim was screaming for help. Vernon continued by informing officers that he observed the male suspect stabbing the victim multiple times and then observed neighbors arrive, telling the male suspect to stop. Then the suspect stopped stabbing the victim and stated, "I'm tired of the shit," and the female victim lying on the ground motionless.


Witness three stated he heard someone yelling outside his residence (405 S Pine Street). When he walked outside, he observed the female victim on the ground. Then he observed another black male pointing a gun at the suspect (who was holding the knife he used against the victim), describing the knife as having a 6 to 8-inch blade and black handle with blood on the blade that was left by the suspect next to silver Honda Accord parked on the driveway at the residence (408 S Pine Street).

Witness four stated he observed his son stabbing the victim multiple times and yelled out to him to stop, or he was going to shoot him. Jermaine stopped and was shortly taken into custody by the police.

Video surveillance shows the suspect, Jermaine Williams, outside the residence with the victim. He re-enters the residence briefly, comes back outside, and then attacks the victim by stabbing her multiple times with the knife.

After arriving at the scene, 408 S Pine Street, I took preliminary photos of the area where the victim was stabbed. I observed the knife used by the suspect located on the ground of the driveway just outside the passenger side of the Silver Honda Accord. The knife is a large kitchen knife with approximately an eight-inch blade and a black handle.

The victim was transported to Advent South Medical Center, Palm Coast, where she was pronounced

The suspect, Jermaine Williams, was transported to the Flager County Sheriff's Office Operations and escorted into an interview room. Williams was informed of his Miranda Warning Rights, and he waived his rights and spoke to Detectives. Williams said that he and his wife have been fighting for a few weeks and he was sleeping in his truck in the driveway. He woke up this morning and went into the home and told Yolanda that he didn't want to live this way anymore and was making efforts to get back together. Yolanda was not responsive to that and she walked outside to go to work and discovered her car would not start. Williams offered to take her to work but Yolanda said she was going to call someone else to come get her.

Williams stated during the argument, Yolanda made a statement to the effect of "Poor Jermaine, do you want me to play you a violin?" Jermaine said after she said this to him, it pushed him over the edge and made him feel like he had nothing else to live for. Jermaine said he then entered the home and went into a kitchen drawer to retrieve a knife. He initially stated he "blacked out" but added that she wouldn't have any other injuries other than stab wounds. Upon further questions, Jermaine said when he exited the residence he approached Yolanda, who attempted to retreat into the street. Jermaine said he then attacked Yolanda but couldn't remember how many times he struck her with the knife, but knew it was more than once. He further advised during the attack, Yolanda attempted to grab the knife.
