

- On May 1, 2025, she had engaged in sexual intercourse with an 18-year-old male, identified as Josiah Morales (DOB: 11/10/2006) (18 years old).
- She had first visited the residence of another juvenile, [REDACTED] (15 years old), on April 23, 2025.
- She and [REDACTED] began to engage in sexual intercourse while in his bedroom at his grandparents' residence, located at 167 Laramie Drive, Palm Coast, FL 32137.
- While at the residence on April 23rd, she was introduced to Josiah.
- Josiah had expressed his interest in her to [REDACTED] to which [REDACTED] replied, telling Josiah that she was only 13 years old.
- After meeting Josiah on April 23, 2025, she saw him at the residence again on April 29th and May 1st.
- On May 1, 2025, between 2300 hours and 0000 hours, she had oral and vaginal sexual intercourse with Josiah.
- On May 2, 2025, between the hours of 0000 hours and 0300 hours, she and Josiah engaged in sexual intercourse for a second time.
- Prior to engaging in sexual intercourse for the second time, there was a discussion between Josiah, [REDACTED] and her about how she needed to get an Uber back to her house to get ready for school.
- After discussing needing an Uber, she went into the bathroom because she became emotional. Josiah followed her into the bathroom.
- While in the bathroom, she felt like Josiah would only help her get home if she had sex with him for a second time.
- As a result, she engaged in sexual intercourse with Josiah for a second time.

- During the two times she and Josiah engaged in sexual intercourse, he did not use a condom.

[REDACTED] went on to inform Deputy Douglas that on May 9, 2025, Josiah attempted to reach out to her via text message. During this text message thread, [REDACTED] stated that Josiah was asking her how she was and indicated that he wished to see her again. At this point, [REDACTED] replied, stating she was fine and was not going to see him again. [REDACTED] then stated that she deleted the text messages between them.

[REDACTED] also informed Deputy Douglas that she did perform consensual sex; however, she felt that she was coerced into these acts with Josiah, because of his age difference and fear of not being able to get back home.

Deputy Douglas communicated with [REDACTED] father, [REDACTED] completed a Willingness to Prosecute Form once he met with Deputy Douglas in person.

On May 13, 2025, I, Detective Prentiss, was informed that Children and Families Child Protective Investigator Beth Jensen, wished to respond to Indian Trails Middle School (ITMS) to conduct a fact-finding interview with [REDACTED]. Shortly after, Detective Gordon and I responded to ITMS. During our conversation with [REDACTED] she made the following statements:

- On April 23rd at approximately 2300 hours, she snuck out of her residence while her parents were sleeping.
- Shortly after sneaking out, an Uber, which [REDACTED] had purchased to pick her up, drove her to [REDACTED] grandparents' residence at [REDACTED].

Further conversation with [REDACTED] led to her explaining the second time she visited [REDACTED] house on April 29, 2025. While explaining this visit [REDACTED] made the following statements:

- [REDACTED] told Josiah that she was 13 years old and she would not do "anything" with him (in reference to sexual activities).

[REDACTED] concluded the fact-finding interview by explaining the third time she visited [REDACTED] residence. While explaining this occurrence, [REDACTED] stated the following:

- Josiah was able to receive her phone number from [REDACTED] phone.



- Josiah invited her to [redacted] residence.
- Josiah communicated with her through text message using his email and phone number of:
 - josiah.morales11006@gmail.com
 - 386-276-5304
- She arrived at [redacted] residence on May 1, 2025, at approximately 2300 hours.
- Josiah kept telling her that [redacted] was a bad guy because he talked to a lot of girls.
- Josiah told her that if [redacted] grandfather saw her there, she needed to tell him that she was 17 years old.
- After sitting on the couch together, Josiah brought her to the bathroom, where he proceeded to remove his vape, two THC cartridges, and three condoms from his backpack.
- Josiah then began to move the bathroom rugs, shoving them underneath the bathroom door.
- He then proceeded to tell her that “we can turn on the shower, so they don’t hear,” to which she stated, “I don’t want to do it (sexual intercourse) in here because it’s gross.”
- At this point, she and Josiah relocated back to the couch in the living room.
- While lying on the couch, Josiah asked her if he could leave hickey marks on her breasts, to which she agreed.
 - Josiah then proceeded to leave three hickeys on her right breast.

It is important to note, [redacted] became visibly upset and had difficulty speaking while explaining what occurred after. Emily provided the following statements of what occurred during the remainder of the evening:

- Josiah then took her back into the bathroom.

- Josiah proceeded to move the bathroom rugs against the door and turn the shower on.
 - She and Josiah then engaged in vaginal sexual intercourse.
 - Josiah did not use the condoms he removed from his backpack.
 - Josiah then told her that she could not be doing “things” (sexual activities) with [REDACTED] if they were going to also be doing “things.”
 - After she engaged in sexual intercourse with Josiah and [REDACTED] they both began to get upset and make fun of her.
 - She then began to cry because they were attempting to push her out the door, and she was worried she would not have a way to get home.
 - Josiah then began hugging her to try and calm her down, along with leading her into the bathroom for the third time.
 - Once in the bathroom, Josiah then pushed the rugs under the crevasse of the door again.
 - Josiah then placed a towel on the toilet seat, pulled his pants down, and proceeded to look at her.
 - She was thinking that if she did not have sexual intercourse with Josiah again, he would not help her get home.
 - She then had vaginal sexual intercourse with Josiah again.
 - She replied to Josiah by stating that she “felt like if she did not do something (have sexual intercourse) with him, then he would not have gotten her home,” to which he stated he was sorry she felt that way.
- Later that week, on May 9, 2025, Josiah texted her cellphone (386-627-1661) asking her how she was doing. [REDACTED] informed him that she was fine, but she was not going to be able to sneak out again.

Due to the offense taking place a week prior, an emergency CPT was not conducted at this time, nor was a sexual assault examination kit completed at this time.


After concluding my conversation with [REDACTED] I began explaining to [REDACTED] what controlled communications were. [REDACTED] advised that she understood the benefits of attempting controlled communications, and she wished to attempt them that day.

With her willingness to attempt controlled communications, these communications were attempted at approximately 1320 hours. During this time, a text message was attempted to be sent to Josiah, and three phone calls were attempted to be made to Josiah. Each attempt was met with negative results.

Additionally, both Luis and [REDACTED] consented to a forensic download of [REDACTED] cellphone. On May 14, 2025, [REDACTED] phone was collected and provided to the Digital Forensics Unit for a download. Later that day, the phone was returned to [REDACTED].

As a result of the continuing investigation, on August 12, 2025, Detective Kusek and I made contact with Josiah at his residence (11 Flemingwood Ln Unit A, Palm Coast, FL 32137). An interview was conducted, and a post-Miranda confession was obtained. During the interview, Josiah made the following statements:

- He met [REDACTED] at his friend's [REDACTED] residence ([REDACTED]).
- He believes that she took an Uber to the residence after [REDACTED] purchased her a ride.
- Marijuana and alcohol were smoked and consumed during the night of May 2, 2025.
- He believed that [REDACTED] was 15 years old at the time.
- [REDACTED] told him that he felt as if [REDACTED] was "feeling him" and attracted to him since she kept looking at him and smiling.
- Later in the evening, [REDACTED] expressed that she was worried that she was not going to be able to get an Uber home.


