ORDERED AND ADJUDGED:

- 1. Plaintiff Darrin McDonald's Motion for Final Judgment against Curtis Ceballos is **GRANTED.**
- 2. That Judgment shall be issued in favor of Plaintiff Darrin McDonald, whose current address is Flat 2, 15 Wenlock Terrace, Fulford, York, UK YO10 4DU and against Defendant Curtis Ceballos in the amount of \$223,807.26, consisting of as follows:
 - a. Compensatory damages for unpaid wages: \$23,333.00;

 - c. Compensatory damages for FLSA retaliation: \$160,000.00.
 - d. Attorneys' fees: \$15,600.00; and

- e. Costs: \$1541.26.
- 3. That the total gross amount of the final judgment (\$223,807.26) in favor of Plaintiff Darrin McDonald shall bear interest at a rate established by the Office of the Chief Financial Officer, pursuant to \$55.03 Florida Statutes, for all of which let execution issue forthwith.
- 4. It is further ordered and adjudged that Defendant Curtis Ceballos shall complete under oath the Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on Plaintiffs' attorney at Addington Law, 9471 Baymeadows Road, Suite 406, Jacksonville, Florida 32256, within 45 days from the date of this final judgment, unless the final judgment is satisfied. A copy of the required Form 1.977 (Fact Information Sheet) is being provided to Defendant Curtis Ceballos contemporaneously herewith. Defendant Curtis Ceballos shall file with the Clerk of the Court a Notice of Compliance with this Order and shall serve a copy of the Notice of Compliance on Plaintiffs' attorney.
- 5. Jurisdiction of this case is retained to enter further orders that are proper for execution and/or garnishment, and to compel the Judgment Debtor (Curtis Ceballos) to complete Form 1.977, including all required attachments, and serve it on the Judgment Creditor's (Darrin McDonald) attorney.
