

On 10/22/15 at approximately 1255 hours, I (DS Wood) responded to 2 Poinbury Dr, Palm Coast, FL 32164 in reference to a report of a violation of a final order of injunction for protection against domestic violence without minor child(ren) (after notice), case number 2015 DR 000051, signed by Judge Orfinger on 01/29/15, and severed in person to Keith Johansen. Upon arrival, [redacted] stated that on 08/28/15 at approximately 0851 hours she received a Facebook message and friend request from Brandi Celenza, who she later determined was the girlfriend of Keith Johansen. [redacted] stated, and provided documentation, that Brandi had asked her questions about her son. [redacted] stated that during the initial communication she did not know that Brandi was the girlfriend of the father of her son and the respondent to the above injunction. [redacted] advised that Brandi also wrote that her son was adorable and asked who the father was. [redacted] stated that she had blocked Brandi from her Facebook account, due to not knowing her and the strange questions about her son, but later went back and unblocked her. [redacted] stated that was when she discovered Brandi and Keith were boyfriend and girlfriend as Brandi had posted a photo of herself and Keith in an intimate embrace on her Facebook cover page.

[redacted] further stated that on 09/05/15 at approximately 1400 hours (sometime in the afternoon), at 220B Palm Coast Pkwy, Palm Coast, FL 32137, her place of employment, that was indicated in the final order of injunction for protection against domestic violence without minor child(ren) (after notice), Keith was observed in the parking lot by her. [redacted] stated that Keith also entered the adjacent business, the 7-11 convenient store, where he had been employed but no longer worked there due to the

stated that on 10/22/15 at approximately 1103 hours, at 174 Cypress Point Pkwy, Walmart, Palm Coast, FL 32137, she observed Brandi walking <sup>OUT OF Bkwy</sup> into the business as she was walking <sup>IN Bkwy</sup> out. stated that Brandi stopped, pulled her cell phone from her rear pocket, and began to video record her.

provided a voluntary written statement in regard to receiving the Facebook messages from Brandi as well as observing Keith in the parking lot of her employment. stated that she did not know who Keith spoke to in the 7-11 while he was there but he knew the employees having been a former employee of the business. further stated that she did not know who Brandi was and had never met her or been former friends with her. stated that the Facebook friend request was a surprise and she informed Brandi she did not know her. advised she could only conclude that Brandi had contacted her on Keith's behalf to obtain information about their minor son who he had never scene.

On 09/24/15 completed an affidavit of violation with the clerk of the court in regard to the violation that occurred on 08/28/15 and 09/05/15. stated that she <sup>Bkwy</sup> was later <sup>Bkwy</sup> contacted by the State Attorney's Office (SAO) who informed her that she needed to contact law enforcement to have a report completed as well as a 707 for further action by their office.


