<b>NARRATIVE</b>						The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the <u>7th</u> day of <u>April</u> , <u>2018</u> , at approximately <u>1037</u> <input checked="" type="checkbox"/> a.m. <input type="checkbox"/> p.m. at <u>23 Felter Lane Palm Coast</u> within <u>Flagler</u> County, violated the law and did then and there: Charge 1: Keith John Allen Johansen did knowingly shoot Brandi Ruth Celenza with a 9mm handgun once in the center of her chest and once in her right breast resulting in her death.  Furthermore,  On April 7, 2018, at approximately 10:37am, Flagler County Sheriff's Office Communications Division received a 9-1-1 call for assistance from a male whom later identified himself as Keith Johansen. Johansen requested an officer respond to his location, which he provided as 23 Felter Lane (Palm Coast FL). Johansen stated that he was in the shower, heard gunshots, and he thought his wife (Brandi Ruth Celenza) shot herself in his bedroom. When asked by the Communication Specialist where on her body she was shot, Johansen stated that he did not know, he could not see it.

Johansen stated that she (Brandi) was lying down, right next to the bed. Johansen stated that he could not see any blood (on Brandi). When asked by the Communications Specialists if he could see a gun, he replied yes and that he was not going to move it. Johansen identified the gun as a 9mm. Johansen stated that he could not see any part of Celenza's body that he could apply pressure to. Johansen then stated that he could see (a wound) "in the ribs". The communication Specialist asked Johansen if he believed this was done by Celenza to harm herself or if it was accidental. Johansen state that he believed it was accidental. Johansen then stated that Celenza was breathing when asked.

Johansen stated that he had not touched the gun. The Communication Specialist asked Johansen if he was applying pressure to the wound. Johansen replied that there were two guns on the floor and he was thinking that she might have dropped them. Again, the communication Specialist asked if he was applying pressure and Johansen stated that he was wet, sliding on his floor and that he could not see it (referring to the wound). Johansen stated that he did not want to risk sliding and hurting Celenza or have the guns go off. Again, Johansen stated that he could not apply pressure to the wound because there was too much stuff around her. When asked if he was alone in the house, Johansen stated that he and his kid where there.

Keith Johansen provided a recorded statement to law enforcement with numerous inconsistencies that led investigators to believe this incident was not accidental. Also in his interview, Keith Johansen told investigators he was alone with Brandi and her six-year-old child at the time of her death, the residence was secure with no signs of forced entry, and he was sure that Brandi was not suicidal and did not kill herself. On April 9th, 2018, Dr. Bulic conducted an autopsy at the District 23 Medical Examiner's Office and Brandi Celenza's death was ruled as a homicide with manner listed as gunshot.



On April 27th, 2018 this detective obtained the video surveillance from the interior of the residnece. The video surveillance was reviewed and the following information was obtained:

\* On April 5th, 2018 there is a camera within the bedroom where the incident occurred pointing directly to where the deceased was located on April 7th, 2018. On April 7th, 2018 that camera is no longer there and there is no video evidence showing that location.

\*The deceased and Keith Johansen are seen in multiple video segments within the master bedroom in clear, heated arguments on April 5th, 2018.

\*On April 7th, 2018 the camera angle in the master bedroom (location of the murder scene) is no longer there, or recording. There is a camera angle in the dining room area that is motion activated that shows no subjects other than Keith Johansen, the deceased and her child within the residence and the front door is locked and secure.

\* Also on April 7th, 2018 at 1033 hours Keith Johansen is seen on video surveillance with a shirt and boxers on in the living room area and grabs the pair of jeans he is wearing at the time of the 911 call at 1037 hours. At 1033 hours you can hear on audio of the video surveillance approximately 2 seconds of Keith's voice in an argumentative manner and then the motion activation is no longer active on the cameras. At 1037 hours Keith is seen and heard on video surveillance with 911 telling the 911 operator he is checking for injuries on the victim while he is clearly depicted removing narcotics evidence in the living room and hiding it prior to law enforcement arrival. He is not checking the body for injuries or looking for the location of injuries.
