It is further ordered that you shall **comply** with the **standard conditions** of probation listed on the reverse side of this Order as well as the following special conditions of probation:

IF CHECKED, YOU WILL:

- (1) Be confined in the Flagler County Jail for a period of 29 days/months. You will be given credit for _____ days time served. Upon release from confinement defendant shall forthwith report in person to the Flagler County Probation Office, 212 S. Railroad Street, Bunnell, FL.
- (2) Hereby fined \$ _____ plus costs in amount of \$ 203.
- (3) Pay State Attorney Costs of prosecution in the amount of \$ 50.
- (4) Pay Arresting Agency Investigative Costs in the amount of \$ 50.
- (5) Pay the sum of \$ _____ as the reasonable costs of representation, if represented by the Public Defender.
- (6) Pay all fines and costs assessed herein within _____ days of the date hereof.
- (7) Perform 240 hours of community service as directed. (Each 50 hours, or portion thereof, of community service ordered requires pre-payment of a \$10.00 insurance fee.)
- (8) Undergo an evaluation and complete any treatment/education program as recommended by the evaluator/counselor for the following:
 - Substance Abuse Anger Control
 - Aggressive Behavior Domestic Abuse
 - Other _____
- (9) Participate in counseling, AA/NA meetings and defendant shall submit to urinalysis, chemical tests, breathalyzer as directed by an approved agency until officially discharged by written notice. Defendant shall complete any program recommended by evaluator/counselor at his/her own expense.
- (10) Enroll in and complete an approved counseling program for the following:
 - Worthless Check Petit Theft
- (11) Enroll in and successfully complete the GED course.
- (12) Obtain a valid driver's license within _____ days.
- (13) Other special conditions: Defendant agrees to relocate to State of Washington as a condition of probation w/in 60 days contact FCP w/in 24 hrs
- (14) Pay restitution in the amount of \$ _____ within _____ days. if judgment shall be entered for costs to Ft-S.

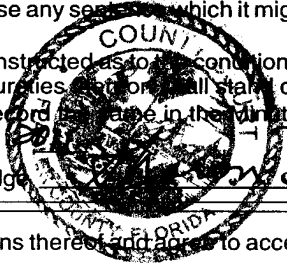
