- XII) INTERCEPTION OF ORAL COMMUNICATION

SPECIFICATIONS OF CHARGES::

COUNT I: KIMBERLE WEEKS, on or about April 7, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Virginia Smith, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT II: IN THAT KIMBERLE WEEKS, on or about May 6, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Shannon Brown, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT III: IN THAT KIMBERLE WEEKS, on or about July 11, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Michael Coomans, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT IV: IN THAT KIMBERLE WEEKS, on or about August 20, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Melissa Moore-Stens, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT V: IN THAT KIMBERLE WEEKS, on or about August 25, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Albert Hadeed and/or Charles Ericksen, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT VI: IN THAT KIMBERLE WEEKS, on or about September 12, 2014, in the County of FLAGLER and State of Florida, did intentionally disclose, or endeavor to disclose, to any other person the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication or did intentionally use, or endeavor to use, the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication, contrary to Florida Statute 934.03(1)(c) and (d). (3 DEG FELONY)

COUNT VII: IN THAT KIMBERLE WEEKS, on or about September 15, 2014, in the County of FLAGLER and State of Florida, did intentionally disclose, or endeavor to disclose, to any other person the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication or did intentionally use, or endeavor to use, the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication, contrary to Florida Statute 934.03(1)(c) and (d). (3 DEG FELONY)

COUNT VIII: IN THAT KIMBERLE WEEKS, on or about September 17, 2014, in the County of FLAGLER and State of Florida, did intentionally disclose, or endeavor to disclose, to any other person the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication or did intentionally use, or endeavor to use, the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication, contrary to Florida Statute 934.03(1)(c) and (d). (3 DEG FELONY)

COUNT IX: IN THAT KIMBERLE WEEKS, on or about September 19, 2014, in the County of FLAGLER and State of Florida, did intentionally disclose, or endeavor to disclose, to any other person the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication or did intentionally use, or endeavor to use, the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication, contrary to Florida Statute 934.03(1)(c) and (d). (3 DEG FELONY)

COUNT X: IN THAT KIMBERLE WEEKS, on or about April 3, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Kenneth Detzner and/or J. Andrew Atkinson and/or Ronald Labasky and/or Gary Holland, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT XI: IN THAT KIMBERLE WEEKS, on or about April 4, 2014, in the County of FLAGLER and State of Florida, did intentionally disclose, or endeavor to disclose, to any other person the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication or did intentionally use, or endeavor to use, the contents of any wire, oral, or electronic communication, knowing or having reason to know that the information was obtained through the interception of a wire, oral, or electronic communication, contrary to Florida Statute 934.03(1)(c) and (d). (3 DEG FELONY)

COUNT XII: IN THAT KIMBERLE WEEKS, on or about September 18, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Gerry Hammond and/or Whitney Anderson, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)
