reached the driveway of 15 Regent Ln, he produced what appeared to be a black handgun from the waistband/front pocket area of his pants and placed it on the ground. Deputy Stanford then ordered Littlefield and Raimundo to lay down on their stomachs in the center of the street.

Once the pair was on their stomachs, Deputy Stanford advised Deputy N. Drew to secure Littlefield in handcuffs while Deputy Stanford covered Raimundo with his agency issued firearm. Once Littlefield was secured, Deputy Stanford placed Raimundo in handcuffs with the assistance of Deputy K. Perkins. Littlefield and Raimundo were then moved behind Deputy Stanford's patrol vehicle by other deputies on scene. Deputy Stanford then searched the area and located the firearm that Littlefield placed on the driveway. It was a black semiautomatic Glock 17 bearing serial number SYD060. Deputy Stanford then located two additional firearms in the front yard of 17 Regent Ln. One black Semiautomatic Taurus 9mm and one black WASR-10 AK-47 rifle with tan/yellow wooden buttstock and foregrip bearing serial number A1-45164-15 RO. Deputy Stanford cleared the AK-47 of ammunition and found it to have one 7.62x39 round in the muzzle, making the firearm ready to be fired upon pulling the trigger. The AK-47 had a black 30 round magazine containing 18 additional 7.62x39 live rounds.


The AK-47 and Glock firearms were secured and submitted to the Flagler County Sheriff's Office Evidence department.

The Taurus belonged to Raimundo and was returned to his person on scene once he was cleared of any wrongdoing.

Deputy Harrison arrived on scene. He met with the victim and two (2) witnesses in a blue Chrysler Pacifica bearing Kentucky tag "HSV496". The victim was identified through his Florida Driver's License and Andru Rivera. Andru stated the following:

Andru was parked on Regent Lane, awaiting one of his co-workers as the group works for a solar company. While parked on the side of the road not obstructing traffic, he was alerted to an aggressive banging on his driver's side window. The noise sounded as if a metal object was hitting the window. Andru rolled the window down, and observed a white male holding an AK-47 style rifle in a hostile manner. The white male began screaming expletives toward Andru and his companions, telling them they don't belong in the area, and they needed to leave. As the male escalated, the male pointed the weapon directly at Andru ordering them to leave. Andru attempted to explain to the male that he was there on business however, after the male pointed the AK-47 style weapon at him, he agreed to leave

the area.

In the front passenger seat of the Chrysler, was a witness identified as George Neacsu. In the rear left passenger seat, was a witness identified as Joshua Perez through his Florida Driver's License.

The witness' statements mirrored that of Andru's statement.

Andru and the witness did not wish press charges and signed the Waiver of Prosecution form. They did not wish to provide a sworn written statement.

Andru was provided with a Victim's Right's Brochure and completed the Victim's Right's to Confidentiality form.

Upon Deputy Schragers arrival, she stated she assisted Deputy Drew with assisting Roland who was later identified, to his feet after he was handcuffed on the roadway.

As Deputy Schragers began to walk Roland to Deputy Stanford's patrol vehicle, Roland began to state he observed a dark colored vehicle across the street from his residence. Roland stated he believed the occupants of the vehicle were "casing" his residence.

Before Roland gave any further statements Deputy Schragers advised Roland of his Miranda Warning at approximately 2045 hours, to which he understood with stating "yes". Roland continued to state that the occupants of the vehicle advised they were waiting for their friends to make a sale at the house with a green roof. Roland continuously stated there was no house on the street with a green roof. Roland stated he took his AK-47 rifle and had it at his right side pointed to the ground. Roland stated he approached the vehicle and told them to leave the area. Roland stated the vehicle then left the area. Roland then went to his neighbor's door, Keith Raimundo, for "help". Roland had an odor of alcoholic beverage emitting from his breath while Deputy Schragers was speaking to him.

Roland stated once he saw Law Enforcement, he dropped the AK-47 style rifle and listened to orders given by Law Enforcement. Roland stated his AK-47 was still in the grass as well as a Glock 17 handgun. After obtaining Roland's initial statement, Deputy Schragers began to assist other Deputies on scene and advising Sergeant Kandour of my findings thus far.

Upon my arrival, I spoke with Keith Raimundo, who was later positively identified by his Florida Driver's License.

Keith stated he was in his residence getting ready to watch TV with his wife, until Keith heard a knock on his door. Keith stated, as he opened the door, he observed Roland Littlefield with a long gun in his possession. Keith explained that Roland advised to him that there was a truck with occupants inside "casing" the area. Keith stated he grabbed his gun that he uses for protection and went outside his residence with Roland. As Keith got outside, Keith advised Roland that he did not see any truck in the area. Keith stated during this time, that he believed Roland to be intoxicated due to witnessing him consume alcohol earlier in the evening.

Keith stated as they were outside looking for the truck, Roland supposedly saw the truck with the headlights out. Keith advised both of them hid behind a vehicle and then saw the vehicle they thought was the truck, put on blue and red flashing lights. Keith completed a sworn written statement.

I made contact with Julio Angeles, positively identified by his Florida Driver's License, who stated he works for a Solar company, Windmar Solar. Julio stated, he was in residence in reference for a business appointment. Julio stated when he came outside, he saw Law Enforcement and did not know what was going on.

I made contact with Kerson St Remy, positively identified by his Florida Driver's License, in which he stated he works with Angeles and was with him during the time of the incident. Kerson stated when he came outside of the residence, he did not know what was going on. Both Julio and Kerson completed a Witness Statement Form.


Upon making contact with Roland, he stated he consumed 3 Coors Light beers, and 1 Peanut Butter Whiskey. Roland stated he started consuming alcohol around 1800 hours up until the time of the incident.

Based off what was observed by Law Enforcement upon their arrival, the statements given, and what was observed during the time of the incident, Roland was placed under arrest for the following charge:

-Use of Firearm Under the Influence of Alcohol

Roland was transported to the Flagler County inmate facility without incident.
