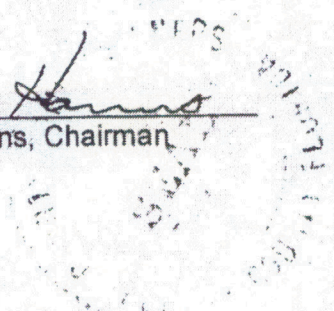
SECTION II. REPEAL AND EFFECTIVE DATE. This Resolution shall repeal and supersede Resolution 2010-33 and take effect immediately.

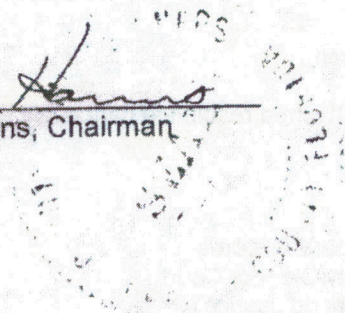
