**NOTICE OF REVOCATION AND RESCISSION  
OF SIGNATURE AND CONTRACTUAL AGREEMENT**

I, Alan S. Lowe, am capable of making this document as well as being personally acquainted with the facts as stated herein.

I, Alan S. Lowe, do hereby revoke and rescind my personal signature both original and reproduced, and any power or authority derived therefrom, as found on page 2 of 2 on the Internal Revenue Service "Income Tax Examination Changes", Form 4549-CG (Rev. 10-90) and signed by me on or about 6/13/92, for the following facts and reasons:

- 1) I was confronted with such menacing verbal utterances as, "seizure, penalties, levy, lien," and the like, by both the examiner Gina Sewell, and an IRS. employee who is as yet unknown.
- 2) I was in a state of extreme duress at the thought of my home and property being seized.
- 3) I was without lawful counsel.
- 4) I was taken to a separate room and left alone thereby increasing the stress under which I was expected to comprehend the situation.
- 5) Knowing the obvious duress I was placed under, no Internal Revenue Service employee or agent ever explained to me that I was waiving my substantive rights and immunities and that in actual fact waived all rights of remedy and recourse.
- 6) Had I been given more than the few minutes allotted to comprehend the situation and had the facts in statement "5" above ever been explained, I would never have signed said contractual agreement.

It is therefore self evident by the facts given above that said contractual agreement is on its face unconscionable and as such signed in error, thus I, Alan S. Lowe, now claim my right to revoke my signature and to annul and make void ab initio, said contractual agreement.

All references to the USC. and the filing of this Document in the Public Records is for the purpose of remedy and recourse only. No grant of jurisdiction is to be assumed.
