The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 9th day of November, 2022, at approximately 0645 a.m. <input checked="" type="checkbox"/> p.m. at 34 Clermont Court; Palm Coast, Florida 32137 within Flagler County, violated the law and did then and there:					
On November 9, 2022, at approximately 0256 hours, the Flagler County Communications Center (FCCC) received a 911 call from Rebecca Sesnowich (09/24/1951). Rebecca, a resident of 21 Clermont Court in Palm Coast, advised that a man was knocking on her door advising that he was attacked by his son. Rebecca advised that the male appeared to be "beaten up" and his face was bleeding. Another caller, Deborah Zimmerman (02/01/1954), called 911 to advise that there was a bloody man outside of her residence (15 Clermont Court) who was requesting her to call 911.					
Upon the arrival of patrol deputies, contact was made with Clint Ingram (01/03/1974) who was wearing dark in color shorts and a white t-shirt. Multiple blood stains were visible on Clint's clothing. Clint stated, "my son attacked me, I need help" as well as "call the ambulance, my dad is on the floor". Clint explained that his son, later identified to be Luke Ingram (12/13/2002), has schizophrenia and came to visit him at his residence (34 Clermont Court in Palm Coast) on the night of November 8, 2022. Clint stated that his father, Darwin Ingram (02/21/1937), was on the floor of his residence, bleeding and in need of medical attention. Clint further explained that he

believes Luke was outside of the residence looking for him.

Patrol deputies responded to the residence of 34 Clermont Court. Deputies knocked on the door of the residence and announced their presence; however, there was no response. Due to exigency, entry to the residence was made at which time Luke was observed standing in the living room next to an unconscious white male, who was lying on his back on the floor with a large amount of blood on his person and surrounding him. It should be noted that Luke was only wearing a dark pair of shorts at this time. Luke was ordered outside of the residence, to which he complied and stood on the front porch area. Luke was given verbal commands to turn around and walk backwards towards patrol deputies; however, he did not comply. Luke was then given verbal commands to get onto his knees and, again, refused to comply with commands. Luke began to drop his hands near his side and appeared to be tensing his body. Luke, then, turned his left foot as if he was going to make entry back into the residence. Due to such, Deputy Quiroga-Joya deployed her agency-issued Taser, briefly incapacitating Luke and causing him to fall backwards. Deputy Finn, Deputy Mortimer, and Deputy Quiroga-Joya quickly approached Luke in attempt to secure him while he was down. Luke continued to pull away from deputies, actively resisting being restrained. Deputy Mortimer issued a second Taser deployment in attempt to further incapacitate Luke and allow deputies to secure him in handcuffs. A struggle continued to ensue with Luke on the ground as he was refusing to present his hands and keeping them underneath his torso. A third Taser deployment was issued. Following which, Luke was able to be secured in handcuffs and detained in a patrol vehicle.

The residence was secured, and Palm Coast Fire Rescue (PCFR) responded to the residence. PCFR Paramedic K. Feldman pronounced Darwin deceased at 0324 hours.

Clint was assessed by PCFR on scene and refused medical treatment. Luke was assessed and was medically cleared.

Detective Gordon was notified of the incident and responded to the scene. Upon arrival, contact was made with Clint Ingram. During interviews with Clint, he stated the following to law enforcement:

- Luke has schizophrenia and was acting strange on November 8, 2022. Clint was able to convince Luke, a college student in Georgia, to come to his residence in Palm Coast (34 Clermont Court; Palm Coast, Florida 32137).
- Luke arrived at 34 Clermont Court last night and had dinner with Clint and Darwin. Clint explained that Luke was staring and him and Darwin during dinner.
- After dinner, Clint went to bed and locked his door, due to Luke's behavior.
- Clint could hear Luke and Darwin engaging in conversation about the house dog and about a watch (belonging to Darwin).
- Clint awoke to a growl-like sound and screaming. Upon exiting his bedroom to check on the noise, Clint located his father, Darwin, bloody and unresponsive in the living room area of the residence. Clint, then, encountered Luke who was sitting in a chair located in Darwin's bedroom. Clint told Luke that Darwin needed medical attention, at which time, Clint went to his bedroom to retrieve his phone to call 911. Clint heard Luke say, "no".
- While Clint was attempting to dial 911, Luke confronted Clint and continued to say, "no". Luke engaged in a physical altercation with Clint during which, Luke placed Clint in a choke hold on two (2) separate occasions. Clint advised that during both occasions he felt as though he was going to pass out due to not being able to breathe. Clint described biting Luke's arm during said choke hold in attempts to get away. Clint advised that he and Luke exchanged strikes to each other's persons. Clint stated he was able to get away from Luke and flee the residence.
- Clint advised that he ran down the roadway to attempt to hide from Luke, as he was scared for his well-being. Clint began to knock on numerous doors to try to get individuals to call 911 for assistance.

Clint was found to have the following injuries:

- Laceration of what appears to be a bite mark on the inner right forearm
- Large, raised bump on the back left of his head
- Bloody nose
- Laceration on right thumb
- Scrape marks on both legs
- Swollen area on right ear

Clint's injuries were photographed.

A search warrant for the residence of 34 Clermont Court; Palm Coast, Florida 32137 was approved and signed by Honorable Judge Totten.

The Florida Department of Law Enforcement (FDLE) Crime Scene Investigative (CSI) Unit responded to the scene, as well as the Flagler County Sheriff's Office (FCSO) CSI.

Luke's vehicle was located in the driveway and deputies observed what appears to be a hoodie sweatshirt with red blood stains in the driver's seat along with red brown staining within the driver's compartment of the vehicle.

While the crime scene was being documented and processed, Luke was transported to the State Attorney's Office (SAO) located within the Flagler County Court House (1769 E. Moody Boulevard; Bunnell, Florida 32110).

Upon Luke's arrival, he was placed in an interview room within the SAO. Detective Gordon and SAO Homicide Investigative Unit (HIU) Investigator Quintieri made contact with Luke. It should be noted that Luke was staring and not responding to most questions. No questions pertaining to the incident were asked.

A search warrant for Luke Ingram's person was approved and signed by Honorable Judge Totten for the following evidentiary items: clothing, DNA buccal swabs/standards, swabs of the blood spatter on the body of Luke Ingram, photographs of Luke's clothing and body, a blood sample to test for the presence or absence of prescribed or illegal drugs.

During the execution of the above search warrant on Luke Ingram's person, Luke spontaneously utters, "who did I kill" "who did I almost kill". Luke begins to resist the commands of Detective Gossett, Master Detective Laverne, Deputy Somers, and SAO HIU Investigator Quintieri and attempts to flee the interview room. Due to such actions, law enforcement officers attempt to restrain Luke, who is detained in handcuffs. Luke jumped and was able to move his handcuffs to the front of his person. During the struggle, the following occurs:

- Detective Gossett is bitten by Luke twice (2): once on the arm and once on the chest. The bite to Detective Gossett's chest punctured skin, and a laceration was present.
- Luke continued to resist and attempted to bite law enforcement officers.
- Luke stated, "I will kill you" multiple times to law enforcement officers.

Law enforcement officers tased and struck Luke to attempt to subdue him. Their attempts were successful, and Luke was secured and transported to the Advent Health (60 Memorial Medical Parkway; Palm Coast, Florida 32164).
