On 3/9/2017 at approximately 5:00 PM, the victim (LB) reported to her counselor (Ashley Goetsch) that she had been having an ongoing sexual relationship with an adult male (Jerald Medders) for approximately three (3) months. Due to the fact that LB is currently sixteen (16) years of age, and the suspect is over twenty-three (23) years of age, the allegation is criminal in nature.

The counselor notified the parents, and contacted law enforcement. Deputy Parthemore of the Flagler County Sheriff's Office gathered a sworn statement from the witness, and then responded to the victim's residence. Deputy Parthemore made contact with the victim, and confirmed that a criminal offense was being alleged. Deputy Parthemore was advised that the victim was wearing one (1) of two (2) different pairs of shorts (no underwear) following the most recent incident of alleged sexual intercourse. Deputy Parthemore gathered both pairs of shorts, and submitted them to evidence.

I responded to the victim's residence at approximately 12:00 AM on 3/10/2017. Due to the fact that the alleged offense had occurred within the last 96 hours, I arranged for an emergency Child Protection Team examination and a forensic Child Protection Team interview. The victim was driven to the Daytona Beach office of the First Coast Child Protection Team (210 North Palmetto Avenue, Daytona Beach) by victim advocate Teresa Shaw.

Upon arrival, a medical examination was conducted by ARNP Kristi Pendergrast. Upon the conclusion of the medical examination, a forensic interview was conducted by Ms. Nicole Heise of the First Coast Child Protection Team. The interview in question was video-recorded in its entirety. During the interview the victim made a disclosure of multiple instances of sexual battery. The sole suspect is Jerald Medders, and 6 Zeda Place is the location of all three (3) alleged incidents. During the interview, LB advised that the first incident occurred in the backyard of 6 Zeda Place, the second incident occurred in the garage of 6 Zeda Place, and the most recent incident occurred in his daughter's bedroom at 6 Zeda Place.

During the interview LB advised that Jerald Medders has been telling her that she is attracted to him sexually since she was approximately 13 years old. LB advised that Jerald used his relationship with her parents to get closer to her. LB advised that Jerald would come to her house, talk to her parents, and then become "touchy feely" with her. According to LB, Jerald has constantly told her that she has "provoked" him to have sexual intercourse with her, and that it would be her fault if they got caught. LB stated that she tried to walk away from having sexual intercourse with him, and Jerald would tell her that he feels bad and that it was okay, encouraging her to remain.

The victim advised that the suspect has spoken to her on the telephone regarding their sexual relationship in the past, and that she believes he would do so again in the near future. At this time, a controlled phone call between the victim and the suspect appears to be the best course of action.

LB explained to me that when she speaks with Jerald Medders over the telephone, she contacts him on his cellular phone number of (386) 986-5218. LB explained that she typically speaks with Jerald in the evening. LB advised me that she and Jerald have spoken on the telephone about their sexual relationship in the past. According to LB, (386) 986-5218 is the only number she has ever called in order to speak with Mr. Jerald Medders.


On 3/10/2017 at approximately 6:00 PM, I responded to LB's residence, where I made contact with LB. The purpose for my visit on this date and time was to attempt a controlled telephone call with the suspect, Jerald Medders.

On 3/10/2017 at approximately 6:11 PM, LB called (386) 986-5218 from her house phone. LB later advised me that she was certain beyond a reasonable doubt that the person she spoke with was one, Jerald Medders, who resides at 6 Zeda Place, Palm Coast, FL. The conversation in question was recorded in its entirety, and uploaded to AEGIS/LERMS. A brief synopsis of the conversation, along with several direct quotes from the conversation is as follows:

LB calls and speaks to Jerald Medders, who asked her what happened. Jerald almost immediately asks LB why law enforcement had recently been at her house. LB tells Jerald that the reason for this was because she was in trouble. Jerald asks LB what she has done to get into trouble, and LB is evasive in answering Jerald, telling him that she is fine. Jerald states that he attempted to speak with her mother earlier, and she walked away from him. LB tells Jerald that her mother hasn't been feeling well. Jerald tells LB that he has been "an outlaw" for his entire life, and he knows law enforcement "down to a science."

LB tells Jerald that her parents think the two of them are "doing something" and that she does not know what to tell them. Jerald asks LB what she means by this. LB explains that her parents believe it is odd that Jerald is always around her, to which Jerald responds, "Well we can stop that shit...and be friends, you know what I mean?" LB then asks Jerald how he can take back everything that happened. Jerald laughs and states, "come on man". After a long pause, Jerald states that there is nothing to figure out, and that the two of them will be friends for as long as they live around one another. LB tells Jerald that she believes her parents are going to "figure out the whole sexual situation" to which Jerald replies, "well, I don't think so."

Jerald then tells LB, "Well, I don't know, but when you get a chance talk to me okay?" Jerald indicates that he will not speak on the phone any further, and for LB to speak with him in person. Jerald then hangs up the phone on LB.

On 3/11/2017 and approximately 1:21 PM, I received an email from LB's mother. A portion of the email in question is as follows: "Hello Det. Hristakopoulos, I hope this email finds you well. I have continued to talk with our daughter (LB) about the incident. She...revealed and stated the following was told to her: This was her fault because she seduced him. He admitted that he has always had a special interest in her since she moved here. He used us to get close to our daughter. Admitted to her when asked, "How do you look my parents in their face and talk to them after knowing what we've done?" "His reply was, "I feel bad, but I do it any way. I'm a career criminal and this is what I do." She is different than everyone else. No one would want her because she is different and has problems. No one would ever believe her if she ever said anything sexual happened between them. He has tried to have sexual relationships with his daughter's friends when she and her friends were teens. "

On 3/14/2017 at approximately 3:45 PM, units from the FCSO Investigative Services Division responded to the area of 6 Zeda Place. Detectives Conrad and J. Glasgow outfitted the victim with the audio/visual monitoring devices, while I maintained a visual on the suspect's residence.

On 3/14/2017 at approximately 4:09 PM, LB knocked on the front door of 6 Zeda Place, and Jerald Medders exited the residence almost immediately. LB and Jerald Medders walked to the driveway on 6 Zeda Place, and began having a conversation. The conversation was audio and video recorded in its entirety and uploaded to AEGIS/LERMS. The following is a synopsis of the conversation, including direct quotes:

LB asks Jerald if she can talk to him outside and he agrees to speak with her outside. Jerald tells LB that he's been worried about her. LB tells Jerald that she has missed several menstrual cycles, and that she is concerned about this. She explains that she learned in health class, that even if a man "pulls out" a woman can become pregnant. LB explains to Jerald that she needs his help, because she is worried. Jerald indicates to LB that he doesn't believe she could be pregnant by him.

Jerald asks LB if she hasn't had a period in three months. Jerald then states, "Well we damn sure ain't done nothin' three months ago" to which LB responds, "Yeah we did." Jerald tells LB that there is no way he got her pregnant, at which time LB asks him, "The condom didn't break before or anything like that?" Jerald immediately replies, "No...hell no...no way."

LB asks Jerald what she is supposed to do, and tells Jerald that she needs his help. LB refers to an apparent past sexual episode between the two (2), "...before I went away something happened, you know, between us...you know, the day we were standing outside, and stuff like that and Jade and Jenna came outside?" Jerald responds by stating, "But there's no way, there's just fucking no way." LB explains to Jerald, "I haven't been with anybody else." Jerald immediately states, "I understand that too, but there ain't no fuckin', there ain't no way. There ain't no way (LB), something's just wrong baby you just ain't had it."

LB asks Jerald why he's getting so upset, and he advised her, "Cause it's fucking scary man. You know all I want to do is be your friend and shit man. You know fucking every fucking thing that we've done is wrong baby, you know that. These motherfuckers will lock me up and throw me away the rest of my fucking life man! I fucking raised babies man, I'm in here now with my two fucking grandbabies, I mean...I...it's just, you know that's why I said, 'wait till you're 18, wait till you're 18' we talked and talked and talked and talked about that 100 fucking times."

LB asks Jerald why he is acting like their situation is her fault, and he indicates that it is not. LB asks what they are supposed to do about it, and what they are supposed to do the other day, and about the entire situation, to which Jerald suggests that they "stop" what they have been doing. LB responds by saying, "Stop? But it already happened. You know it happened." Jerald then replies, "I know."

LB then asks Jerald how old he is, to which he states that he is 51 years old. LB suggests that he should know what to do, since he is an adult. LB then states that Jerald is 51 and that she was 15 when they first had sexual intercourse. Jerald does not verbally respond to this in any way.

Jerald states that he is "a smart man" and claims that he has never used birth control in over 20 years with his wife, he states "I've pulled that motherfucker out my whole entire life, never had this happen to me."

LB states, "So then what are we supposed to do about what happened, cause have sex, we did." Jerald replies, "I understand that." LB explains to Jerald that he is the only one she's had sex with and that she is concerned and needs his help because she doesn't know what to do and she is scared. Jerald states that he doesn't know, but they can figure it out.

Jerald states to LB that he is certain she will have her period, and that she won't be pregnant. LB explains that she doesn't believe she will have her period, and states that they began having sex in January, and that it's been "two or three months already". Jerald states that the only thing she can do is take a test, and that he can get one for her. LB states that she is upset because she feels Jerald is denying that they had sex, to which Jerald replies "Ain't nobody said that, ain't nobody said that at all." Jerald and LB speak about her concern regarding the possibility of being pregnant for several minutes, and then LB explains to Jerald that if she has a child, it would definitely be his. Jerald acknowledges this and says "I understand what you're saying." Jerald then states again that he will get her a pregnancy test.

LB states to Jerald, referring to their sex, "this has happened three or four times...and before I left you know it happened too. Remember? Do you remember???" Jerald responds with, "Mmmm hmm. Yeah." LB states, "Did it not happen three times?" Jerald responds by stating, "I know everything, I know everything." Jerald then goes on to explain that he has been stressed out about a lot of things in addition to LB's potential pregnancy.

At this time, LB states "Did we not sleep together? It's only you. It's only been you! Did we not!?" Jerald responds, "Yes, yes, yes, yes!" Jerald then explains that he does not have money to pay for a pregnancy test at the moment, but that he will. Jerald further explains to LB that it could be the medication she is on which has caused her to miss her period. LB explains to Jerald that she is very scared and asks him if it is scary for him as well. Jerald responds by stating, "You fucking right it is man! The whole fucking thing! Wouldn't it have been better to wait until you're 18?" LB asks Jerald how it would look for him to be having sex with a juvenile, and he replies "not good."

Jerald states that he realizes how bad it would look for it to be discovered that he has been engaged in intercourse with a juvenile several times. Jerald tried to comfort LB and tells her that there is no need for her to be nervous. At approximately this time, LB leaves 6 Zeda Place.

On 3/14/2017 at approximately 6:00 PM, I reviewed the audio recording received from LB's contact with Jerald Medders. Upon reviewing the entire audio-recording with Detective Conrad, we determined that the information gathered, supported LB's CPT interview, in which she advised that she and Jerald Medders had engaged in sexual intercourse on three (3) separate occasions. It should be noted that during the first two (2) instances of sexual intercourse, LB was fifteen (15) years old, and during the latest incident she was sixteen (16) years old. During all three (3) alleged incidents the suspect was 51 years old.

At this time, I believed there to be sufficient probable cause that Jerald Medders knowingly and intentionally had sexual intercourse with LB, contrary to Florida State Statute 794.011(4)(a), a first degree felony. There is probable cause that LB and Jerald Medders engaged in sexual intercourse on no less than three (3) occasions.
