**SUBJECT:** Review Committee Recommendation for *All Boys Aren't Blue*

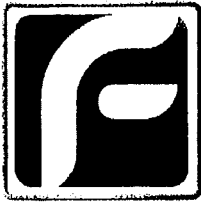

The district strives to provide appropriate educational, intellectual and physical access to resources that provide for a wide range of abilities and differing points of view.

The District Media Review Committee met on December 1, 2021 to review the reconsideration request of *All Boys Aren't Blue*. The committee determined this resource is appropriate for use and should be retained as a resource available to teachers and students in our high school media centers.

The committee further recommends, before this resource is returned into circulation, the district communicate to families the process of "opt-out" for any instructional materials. This "opt-out" process includes media center resources as well. The Teaching and Learning department of Flagler Schools will work with the District Community Information Specialist to communicate these procedures. The committee recommends this communication process occur by January 5, 2022.

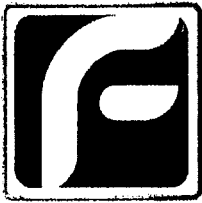
