- Provided interpretive educational programs to schools, special interest groups and civil organizations and coordinated park volunteer work groups.
- Established lines of communication between the park and the Chamber of Commerce, residents of the City and local law enforcement agencies.
- Reported project status and recommendations for long-term planning using statistics of the park's revenues and performance.
