

Prior to working for the Florida Department of Law Enforcement, your Affiant was employed with the Office of the Attorney General's Child Predator Cybercrime Unit for over three and a half years. Your Affiant has over 16 total years of law enforcement experience and holds a Bachelor of Science degree in criminology from Florida State University. Your Affiant is a member of the North Florida Internet Crimes Against Children (ICAC) Task Force and served on the Federal Bureau of Investigation's Child Exploitation Task Force, previously known as the Computer Crimes Task Force, for six years.

Your Affiant has received training and attended seminars in the areas of specialized investigative techniques, including but not limited to: ICAC Investigative Techniques, ICAC Undercover Chat Investigations, Online Grooming, Interview and Interrogation Techniques, Child Victim Interviews, Facebook for Law Enforcement, Basic Data Recovery and Acquisition and Intermediate Data Recovery and Acquisition. Your Affiant has conducted and participated in investigations involving undercover chat sessions, child sexual solicitation, the receipt, transportation, distribution, and possession of child pornography, and identity theft.



On December 11, 2013, based on the investigation, your Affiant obtained a search warrant for the Facebook username http://Facebook.com from November 2012 to November 2013. The search warrant was reviewed and signed by Flagler County Circuit Court Judge Dennis Craig. Your Affiant then executed the search warrant on Facebook Inc. per Facebook's law enforcement records request protocol. On December 19, 2013, your Affiant received from Facebook Inc. the results of the search warrant on Facebook username http://Facebook.com from November 2012 to November 2013. Upon reviewing the results, your Affiant saw that the Facebook account was created on November 25, 2012 and the following information was used in creating it: Name: City/State DOB: Email address: In addition, your Affiant also made note of the following information from the Facebook search warrant results: On April 27, 2013 at 03:59 hours UTC, the Facebook profile and became Facebook friends. It should be noted the above message exchange is only a part of the messages exchanged between the Facebook profile and On March 4, 2014, your Affiant met with the at Flagler Palm Coast High School (FPC), confirmed a student named attended FPC. On that date, your Affiant met with and his at their home located in Palm Coast, Flagler County, Florida. mother confirmed he has a Facebook account in the name which he created approximately two and a half years ago is unaware of anyone else with a Facebook account utilizing the same name as his was 14 years old at the time the above Facebook messages were exchanged. Your Affiant also found in the Facebook search warrant results that between December 1, 2012 and December 3, 2012, the Facebook profile exchanged messages with the Facebook account During this message exchange, the Facebook profile stated "Can I see ur dik" and "Can u take a pic of it now". The Facebook profile stated "she" might give "some head" if he sent the picture. sent a picture of a black male's post-pubescent erect penis. The Facebook profile directed on how to send the picture through Facebook. Upon receiving the picture, the Facebook profile then asked him to "Take a pic of u jerking it". No other pictures were exchanged. It should be noted that these message exchanges are only a part of the messages exchanged between the Facebook profile and Pursuant to the investigation. was identified as
