


The undersigned certifies and swears that there is probable cause to believe the above named defendant, Between Saturday December 23 <sup>rd</sup> 2017 at approximately 11:00am to Sunday December 24 <sup>th</sup> 2017 at approximately 7:30am. at 110 White Hall Drive, Palm Coast FL 32164 within Flagler County, violated the law and did then and there:					
On December 26, 2017 the initial incident was reported to Deputy Malheiros and Deputy Weston. Deputy Malheiros advised that she was briefed of several details by Jon Flositz (complainant). The residence had been checked due to Jon Flositz's step daughter, Ashley Wilson (victim) having obtained strange information about the residence and had called he and his wife, Alissa Flositz (witness). Ashley Wilson had received some strange verbal cues that her husband and defendant, Michael Wilson, had been at the residence and had possibly done something to the residence. Jon Flositz stated that upon him and his wife checking the residence for Ashley Wilson, they discovered strange writing on the back sliding glass door which had the word 'HI!' written in what appears to be in lipstick and with a drawing of two eyes painted above the word. Jon Flositz advised that he and his wife then began to unlock and open the front door but advised that when doing so, the door would not open and appeared to have an object behind the door keeping it from opening. Jon Flositz advised that is when they decided to contact the Flagler County Sheriff's Office to assist with checking the residence.




Deputy Malheiros advised that she and Deputy Weston observed that the handle to the front door of the residence had burn markings around it and that the door had been partially barricaded. Deputy Malheiros gained consent to enter the residence by speaking with Ashley Wilson on the phone. While met with resistance at the front door, Deputy Weston applied a mule kick to the front door and upon doing so, they witnessed a "booby trap" was possibly triggered which caused a large spark. Prior to entering the door way, a check of the doorway revealed that the forceful entry pulled the electrical cords away from the wall and disrupted the rigged device.

Detective Blanton responded to the scene and of an electrical rigging that had been constructed to the front door. It was apparent that a person had modified and rigged electrical devices to the top door lock and lower door handle. One set of electrical wiring appeared to be a cord that had been cut from a lamp's electrical light bulb used for a salt rock lamp in a nearby bedroom. The cord had circular switch for easy on and off power and had the cut end of wiring wrapped into the doors locking features. The other end still had the wall outlet plug in adapter affixed as seen on a standard electrical cord. A secondary set of wires with clamps from a "Viking" multi-amp (up to 15 amps of electricity per the manufacturer) automotive battery charger was also attached to the door locking mechanisms. The mechanism appears to have been rigged so that when the house key was inserted into the top portion, dead bolt locking mechanism, by one hand and then grabbing ahold of the lower portion, door handle, with the other hand, an electrical closed circuit would be established. This would allow electrical current to be able to then flow freely from one hand up the arm through the chest passing the heart and back through the other arm. The items used for rigging this electrical booby trap consisted of two chairs, one high chair, blue tape, shower type rod, electrical cords and wiring, and a battery charger with clamps.

Detective Blanton spoke with Jon Flositz and Alissa Flositz while on scene at the residence. They both explained that when they attempted entry, they never made a connection with both top portion and bottom portions of the door entry mechanisms at the same time. Jon Flositz advised that he had observed the smart cameras in the toilet and had retrieved them from the toilet and had thrown them away into the kitchen trash can. Detective Blanton observed that a salt lamp in one of the bedrooms did not have a bulb and electrical cord attached. Detective Blanton observed that in the kitchen, there was a light bulb on the counter top with its cord cut and removed from it. Also on the counter top spread out were photographs of a sonogram in which Jon Flositz described to be of Ashley Flositz. He advised that Michael Wilson has knowledge of Ashley Flositz being pregnant with his child. Detective Blanton observed in the main bedroom that there were some 'love letter' style sticky notes and letters lying on the bed along with a photo album. The photo album was opened to a page that contained both Michael Wilson and Ashley Flositz together. The photographs were also of a time frame in which Ashley Flositz was pregnant. A search of the residence was performed and it was confirmed that the firearm had been stolen from the residence as well.



Detective Blanton inquired and had family check on Ashley Flositz's status and her whereabouts. Ashley Flositz advised that she was currently driving back from Tennessee and would be back in the area in approximately five hours.

The electrical booby trap was photographed along with the other areas of the residence. Several items were collected for evidence at that time.

On December 27, 2017 at 7:15am, Detective Blanton conducted a video recorded interview with Ashley Wilson. Ashley Wilson appeared to be calm but concerned during the interview and gave sworn testimony to what she had personal knowledge of. She explained the following details during her interview:

- She and Michael Wilson are married and both live at 110 White Hall Drive, Palm Coast FL 32164. They both have a child together, [REDACTED] who is 18 months of age.
- A few months prior, Michael Wilson, had some sort of seizure and fell to the ground, but refused to seek medical attention until later. She stated that up until that point, Michael Wilson, seemed to be a normal person. She stated that since that time, Michael had become very paranoid and temperamental in his behaviors. She further stated that he was later diagnosed as having paranoid schizophrenia.
- On or about November 28, 2017, Michael Wilson was placed under the Baker Act and had since never returned back to their shared residence of 110 White Hall Drive, Palm Coast FL 32164.
- Since the absence of Michael Wilson being away from the residence, she has obtained a revolver firearm that was given to her from Jon Flositz to have at the residence for safety concerns. She stated that she kept the firearm hidden above the cabinets above the stove in the kitchen.
- She stated that she had purchased two smart cameras and had them in the residence in which she would be able to connect and view live video footage from her cell phone.
- She stated that Michael Wilson had called her the week prior to this incident and had apologized for his absence and his behavior and was wishing to be together with her again. She stated that she invited Michael Wilson to join her in Knoxville, TN while she and her children were visiting her father, Roger Hill at his residence for Christmas. She stated that she got Michael Wilson a room at the Extended Stay hotel on the west side of Knoxville and that he arrived for his visit on Thursday, December 21, 2017.
- She stated that by Friday night into Saturday morning at approximately 1:00-2:00am in the morning, she and the family observed Michael Wilson get up from enjoying television time and leave the residence without any explanation. She stated that she received texts from Michael Wilson later on Saturday morning around 9:00am accusing her of cheating on him and that Michael then blocked her number in his phone. She did not speak to Michael Wilson again until the following day when she calmed Michael down on a phone call and told him that his presence was appreciated at her fathers. She stated that she was told by Michael Wilson that he had visited his family in Ohio during this time of absence. He was observed being back in Knoxville on Sunday at approximately 4:30pm.

- She stated she remembers that during Michael's absence from being in Knoxville, she had received an alert on her phone advising her that her smart cameras were disconnected from the internet.
- She stated that upon Michael Wilson's return, he began making concerning comments to her to her that led her to believe that he had been in Florida while away from Knoxville. She stated that Michael inquired about her having a firearm and then told her the exact location of where the firearm had been hidden. She stated that he also inquired about her having cameras in the residence and accused her of getting the cameras to be able to know when or if he were to come to the residence.
- She stated that Michael Wilson made a comment also that raised further alarm. She stated that he told her in person, "when you go up, make sure you use the front door because the garage door is not going to open" and then "but make sure that [REDACTED] isn't with you because I don't want her getting hurt".
- She stated that she later called and told Alissa Flositz and Jon Flositz about the strange conversations and about her concerns for the residence in which they insisted on responding to the residence to check for it out for her.
- She stated that before she had left Knoxville area to travel back to Florida, Michael began insisting that [REDACTED] was to travel in the vehicle with him and that he would follow her to Florida. She stated that after he became verbal and showing aggression towards her, she fled gas station and thinks that the traffic on the highway assisted in their further separation.

On December 27, 2017 at approximately 3:15pm, Detective Hristakopoulos responded 4277 East State Highway 100, Palm Coast FL 32164 (FPL) and made contact with Steven Bray (witness). Steven Bray advised that he works for Florida Power and Light. Steven Bray was shown several photographs of the crime scene in question. Steven Bray provided his own opinions regarding the photographs that he was shown, and his opinions were not intended to reflect the opinion of Florida Power and Light. Steven was provided the photographs in question, but was not provided with any history regarding the incident in question. Steven Bray's title is "Production Lead", and he supervises approximately 28 personnel, consisting of journeymen linemen. Steven Bray advised that prior to becoming a journeyman lineman, he completed approximately 7500 hours of training, and a one (1) year apprenticeship. Steven Bray has approximately fourteen (14) years of experience as a journeyman lineman. Steven Bray appears to have a sound understanding of electric principles, electric circuits, etc.

Based on Steven Bray's examination of the photographs provided to him, he estimated that a person touching the door lock and the door handle of the door in question, would be exposed to approximately 120 volts and approximately one (1) amp. Steven Bray estimated that a person who touched both the door lock/keys, and the door handle simultaneously would have an approximately 80-100% chance of suffering death or great bodily harm. Mr. Bray stated that he believes that there is a great likelihood that a person touching the door lock and the door handle simultaneously would "complete the circuit" and would cause them to squeeze the door knob for an extended period of time, resulting in greater chances of great bodily harm or death. Mr. Bray estimated that approximately 100 out of 100 electricity industry professionals could look at the same photographs provided to him, and estimate the same results.
