- She stated that upon Michael Wilson's return, he began making concerning comments to her to her that led her
 to believe that he had been in Florida while away from Knoxville. She stated that Michael inquired about her
 having a firearm and then told her the exact location of where the firearm had been hidden. She stated that he
 also inquired about her having cameras in the residence and accused her of getting the cameras to be able to
 know when or if he were to come to the residence.
- She stated that Michael Wilson made a comment also that raised further alarm. She stated that he told her in person, "when you go up, make sure you use the front door because the garage door is not going to open" and then "but make sure that isn't with you because I don't want her getting hurt".
- She stated that she later called and told Alissa Flositz and Jon Flositz about the strange conversations and about her concerns for the residence in which they insisted on responding to the residence to check for it out for her.
- She stated that before she had left Knoxville area to travel back to Florida, Michael began insisting that
 was to travel in the vehicle with him and that he would follow her to Florida. She stated that after he became
 verbal and showing aggression towards her, she fled gas station and thinks that the traffic on the highway
 assisted in their further separation.

On December 27, 2017 at approximately 3:15pm, Detective Hristakopoulos responded 4277 East State Highway 100, Palm Coast FL 32164 (FPL) and made contact with Steven Bray (witness). Steven Bray advised that he works for Florida Power and Light. Steven Bray was shown several photographs of the crime scene in question. Steven Bray provided his own opinions regarding the photographs that he was shown, and his opinions were not intended to reflect the opinion of Florida Power and Light. Steven was provided the photographs in question, but was not provided with any history regarding the incident in question. Steven Bray's title is "Production Lead", and he supervises approximately 28 personnel, consisting of journeymen linemen. Steven Bray advised that prior to becoming a journeyman lineman, he completed approximately 7500 hours of training, and a one (1) year apprenticeship. Steven Bray has approximately fourteen (14) years of experience as a journeyman lineman. Steven Bray appears to have a sound understanding of electric principles, electric circuits, etc.

Based on Steven Bray's examination of the photographs provided to him, he estimated that a person touching the door lock and the door handle of the door in question, would be exposed to approximately 120 volts and approximately one (1) amp. Steven Bray estimated that a person who touched both the door lock/keys, and the door handle simultaneously would have an approximately 80-100% chance of suffering death or great bodily harm. Mr. Bray stated that he believes that there is a great likelihood that a person touching the door lock and the door handle simultaneously would "complete the circuit" and would cause them to squeeze the door knob for an extended period of time, resulting in greater chances of great bodily harm or death. Mr. Bray estimated that approximately 100 out of 100 electricity industry professionals could look at the same photographs provided to him, and estimate the same results.
