The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 2ND day of September, 2005, at approximately UNKNOWN a.m. p.m. at 1686 HIGHWAY 100 BUNNELL within Flagler County, violated the law and did then and there: POST MIRANDA THE DEFENDANT DID ADMIT TO TOUCHING AND FONDLING THE VICTIM, A 13 YEAR MINOR. THE DEFENDANT IS A YOUTH PASTOR AT PRAISE ASSEMBLY FOR THE LAST 3 YEARS. THE DEFENDANT STATES THAT THE 13 YEAR OLD VICTIM WAS SITTING IN THE BACK OF THE ROOM WATCHING A MOVIE DURING CLASS. THE DEFENDANT WALKED UP TO THE VICTIM AND PULLED A CHAIR UP NEXT TO THE CHAIR WHERE THE VICTIM WAS SITTING.
