<p>The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the <u>19TH</u> day of <u>MARCH</u>, 2014, at approximately <u>0140</u> <input checked="" type="checkbox"/> a.m. <input type="checkbox"/> p.m. at <u>101 N A1A</u> within <u>Flagler</u> County, violated the law and did then and there:</p> <p>On 3-19-14 at approximately 0140hrs, I responded to 101 N A1A in reference to a physical disturbance called out by Dep. Nunziato. Upon my arrival, I observed the Dep escorting a secured white male to his fully marked patrol vehicle. Once the male was inside the vehicle, I made contact with the Dep and asked what happened. Dep. Nunziato stated that he was on patrol in the area of Finns Bar, 101 N A1A when he was contacted by yelling individuals of a fight taking place in the parking lot of the establishment. Dep. Nunziato said that when he arrived on scene, he saw several people fighting, but was unable to see who made physical contact with who.</p> <p>During my contact with Dep. Nunziato, a crowd was forming with a number of intoxicated individuals who were yelling at each other and I also observed the victim lying on the ground, on his back. At this time, as backup officers arrived, we quickly took control of the scene and filtered out the individuals who played a role in this incident. I then made contact with the only witness who was willing to give a verbal statement, identified as Jenuk Neku. Jenuk said that the altercation took place inside the bar as a verbal argument only between the 3 suspects identified as Vassili Mironov, Joshua Auriemma, Roman Dubinski and the victim identified as Ralph Ortiz. Jenuk said that Ralph left the bar and the three suspects followed him outside. Once outside, Jenuk said that Vassili threw the first punch on Ralph and the other 2 suspects joined in. After several moments of fighting, law enforcement arrived on scene.</p>

Rescue was called for Ralph as he complained of pain in his right leg, he did not appear to have any abrasions or cuts at this time. Ralph was transported to Florida Hospital Flagler by ambulance.

At this time, all 3 suspects were arrested for engaging in a physical altercation with another person, causing the victim to be transported to the hospital and subsequently charged with disorderly conduct. Vassili however was also charged with battery against Ralph as Jenuk said he observed Vissili hit Ralph.

All 3 suspects were transported to the Flagler County Inmate Facility without incident.
